35	<u> 17-108-102. Definit</u>	ions.	
36	<u>As used in this chap</u>	ter:	

1	(1) "Doula" means an individual who is a trained professional
2	and provides nonclinical emotional, physical, and informational support to
3	women, starting during pregnancy and continuing through the postpartum
4	period; and
5	(2) "Health benefit plan" means an individual, blanket, or group
6	plan, policy, or contract for healthcare services issued or delivered in this
7	state by a healthcare insurer, health maintenance organization, hospital
8	medical service corporation, or self-insured governmental or church plan in
9	this state.
10	Subchapter 2 - Certification
11	
12	<u>17-108-201. Doula - Certification.</u>
13	(a) The Department of Health shall issue a certification to be a doula
14	<u>to an individual who:</u>
15	(1) Is eighteen (18) years of age or older;
16	(2) Submits evidence of:
17	(A) Maintaining a certification from a doula certification
18	organization designated by the department under § 17-108-203; or
19	(B) Holding a certificate as a doula by the Doula Alliance
20	of Arkansas issued on or before January 1, 2026; and
21	(3) Submits an application with an application fee of fifty
22	<u>dollars (\$50.00).</u>
23	(b)(1) A certification under this section is valid for two (2) years
24	after the date of issuance.
25	(2) To renew a certification, a doula shall:
26	(A)(i) Complete ten (10) hours of professional development
27	requirements and training over two (2) years.
28	(ii) The department, in conjunction with the Doula
29	Alliance of Arkansas, shall adopt rules relating to the tracking by the
30	department of professional development and training; and
31	(B) Submit a renewal application with a renewal
32	application fee as determined by the department.
33	(c) The department shall create and maintain a registry of certified
34	doulas to be made available to the public.

36	17-108-202. Suspension, revocation, nonissuance, or nonrenewal.

1	(a) The Department of Health may suspend, revoke, or refuse to issue	
2	or renew the certification of a doula for:	
3	(1) Securing a certification under this chapter through fraud or	
4	deceit;	
5	(2) Unethical conduct, gross ignorance, or inefficiency in the	
6	conduct of his or her practice;	
7	(3) Using a false name or an alias in his or her practice;	
8	(4) Violating any provision of this chapter; or	
9	(5) Failing to comply with any of the requirements for issuance	
10	of the certification.	
11	(b) Proceedings under this section shall comply with the Arkansas	
12	Administrative Procedure Act, § 25-15-201 et seq.	
13		
14	17-108-203. Designated doula certification organizations.	
15	(a) The Department of Health, in conjunction with the Doula Alliance	
16	of Arkansas, shall establish criteria for an organization to be designated as	
17	a doula certification organization.	
18	(b)(1) The department shall periodically review the doula	
19	certification organizations designated by the department.	
20	(2) The department may:	
21	(A) Designate additional organizations as doula	
22	certification organizations for the purpose of certifying doulas for	
23	inclusion on the registry of certified doulas; and	
24	(B)(i) Remove the designation of a doula certification	
25	organization previously designated.	
26	(ii) If the department removes a designation, the	
27	department shall provide notice of the removal by publication on the	
28	department's website and specify the date after which a certification by the	
29	doula certification organization no longer authorizes a doula certified by	
30	the doula certification organization to be included on the doula	
31	certification registry.	
32	(c)(l) A doula certification organization seeking designation under	
33	this section shall provide the department with evidence that the doula	
34	certification organization satisfies designation criteria established by the	
35	department.	
36	(2) If the department designates a doula certification	

1	organization under this section, the department shall provide notice of the
2	designation by publication on the department's website for the registry of
3	certified doulas and specify the date after which a certification by the
4	doula certification organization authorizes a doula certified by the
5	organization to be included on the doula certification registry.
6	(d) This section does not prohibit an individual from submitting his
7	or her doula certification to the department without involvement of a doula
8	certification organization.

10	<u>Subchapter 3 - Miscellaneous Provisions</u>
11	
12	17-108-301. Scope of practice.
13	<u>A doula certified under this chapter shall perform only the following</u>
14	types of services:
15	(1) Providing childbirth education;
16	(2) Helping pregnant women navigate the healthcare system;
17	(3) Advocating for pregnant women before, during, and after the
18	<u>birth of a child;</u>
19	(4) Connecting pregnant women with community resources; and
20	(5) Supporting pregnant women with continuous emotional and
21	physical support throughout labor and birth and intermittently during the
22	prenatal and postpartum periods.
23	
24	17-108-302. Patient and personal data and information.
25	(a) Patient and personal data and information accessed or attained by
26	a doula certified under this chapter is exempt from disclosure under the
27	Freedom of Information Act of 1967, § 25-19-101 et seq., and is confidential
28	and privileged as otherwise required by federal law.
29	(b) If a doula certified under this chapter does not maintain the
30	confidential and privileged nature of the patient data or information, the
31	doula shall be subject to any penalty under state and federal law for a
32	breach of confidential patient data or information.
33	
34	17-108-303. Doula compensation.
35	(a) A doula certified under this chapter shall receive compensation
36	for services provided from:

1	(1) The Arkansas Medicaid Program; or
2	(2) A health benefit plan.
3	(b) Services described in subsection (a) of this section shall include
4	without limitation:
5	(1) Four (4) one-hour prenatal visits;
6	(2) Two (2) one-hour postpartum visits;
7	(3) Up to fourteen (14) hours providing support during a
8	hospital delivery; and
9	(4) Up to fifty (50) hours postpartum support during the day or
10	night through sixteen (16) weeks.
11	
12	<u>17-108-304.</u> Rules.
13	(a) The Department of Health shall promulgate rules relating to the
14	certification and regulation of doulas under this subchapter and relating to
15	the designation of an organization as a doula certification organization.
16	(b) Within six (6) months of the effective date of the rules of the
17	Department of Health, the Department of Human Services shall promulgate rules
18	relating to the reimbursement of doulas under the Arkansas Medicaid Program.
19	
20	SECTION 2. DO NOT CODIFY. Rules.
21	(a) When adopting the initial rules required under this act, the
22	Department of Health shall file the final rules with the Secretary of State
23	for adoption under § 25-15-204(f):
24	(1) On or before January 1, 2026; or
25	(2) If approval under § 10-3-309 has not occurred by January 1,
26	2026, as soon as practicable after approval under § 10-3-309.
27	(b) The department shall file the proposed rules with the Legislative
28	Council under § 10-3-309(c) sufficiently in advance of January 1, 2026, so
29	that the Legislative Council may consider the rules for approval before
30	<u>January 1, 2026.</u>
