1	(a) Who are less than seventeen (17) years of

8	(2) "Collaborative relationship" means a cooperative working
9	relationship between a prescribing psychologist or a psychologist with a
10	conditional prescription certificate and a licensed physician in the
11	provision of patient care, including diagnosis and cooperation in the
12	management and delivery of physical and mental health care;
13	(3) "Conditional prescription certificate" means a document
14	issued by the Arkansas Psychology Board to a licensed psychologist that
15	permits the holder to prescribe psychotropic medication under the supervision
16	of a licensed physician under this subchapter;
17	(4) "Physician" means a person licensed to practice medicine and
18	surgery or osteopathic medicine and surgery in this state who is board-
19	certified in family medicine, internal medicine, pediatrics, psychiatry, or
20	another specialty who prescribes medications for the treatment of a mental
21	disorder to patients in the normal course of the person's clinical medical
22	practice pursuant to joint rules adopted by the Arkansas Psychology Board and
23	<u>the Arkansas State Medical Board;</u>
24	(5) "Prescribing psychologist" means a licensed psychologist who
25	holds a valid prescription certificate;
26	(6) "Prescription certificate" means a document issued by the
27	Arkansas Psychology Board to a licensed psychologist that permits the holder
28	to prescribe psychotropic medication under this subchapter; and
29	(7)(A) "Psychotropic medication" means a medicine that:
30	(i) Is not dispensed or administered without a
31	prescription; and
32	(ii) Has been explicitly approved by the United
33	States Food and Drug Administration for the treatment of a mental disorder,
34	as defined by the most recent version of the:
35	(a) American Psychiatric Association's
36	Diagnostic and Statistical Manual of Mental Disorders; or

1	(b) International Classification of Diseases.
2	(B) "Psychotropic medication" does not include narcotics.
3	
4	17-97-602. Authority over physicians supervising certain
5	psychologists.
6	In consultation with the Arkansas Psychology Board, the Arkansas State
7	Medical Board shall establish the following by rule:
8	(1)(A) Specific minimum standards for the appropriate
9	supervision of a psychologist prescribing medication under a conditional
10	prescription certificate.
11	(B) The standards under subdivision (1)(A) of this section
12	shall include requiring a physician serving as a supervising licensed
13	physician to notify the Arkansas State Medical Board of the identity of the
14	psychologist the physician is supervising and any change in the status of the
15	supervisory relationship; and
16	(2)(A) The process for initiating and conducting disciplinary
17	proceedings if a licensed physician fails to adequately supervise a
18	psychologist prescribing psychotropic medications under a prescription
19	<u>certificate.</u>
20	(B) The deliberations of the Arkansas State Medical Board
21	in making a determination under subdivision (2)(A) of this section shall be
22	accounted for in the rules adopted under this section.
23	
24	17-97-603. Requirements for prescription certificates for
25	<u>psychologists — Joint rules.</u>
26	(a) The Arkansas State Medical Board and the Arkansas Psychology
27	Board, by agreement of both boards through a joint rule-making process, shall
28	adopt joint rules regarding:
29	(1) Education and training requirements for prescription
30	certificates; and
31	(2) Specific minimum standards for the terms, conditions, and
32	framework governing a collaborative practice agreement and for governing the
33	limitations on the prescriptions eligible to be prescribed and populations
34	eligible to be prescribed under this subchapter.
35	(b) The Arkansas State Medical Board shall consult with the clinical
36	and counseling psychology doctoral programs at institutions of higher

1	education in the development of the rules pertaining to education and
2	training requirements.
3	
4	17-97-604. Prescribing drugs and medicine — Authorization and
5	restrictions.
6	(a) Except as provided in subsections (b) and (c) of this section, a
7	psychologist shall not administer or prescribe drugs or medicine.
8	(b) A licensed psychologist holding a conditional prescription
9	certificate may prescribe psychotropic medication under the supervision of a
10	licensed physician under this subchapter as provided in § 17-97-605(c).
11	(c) A prescribing psychologist may prescribe psychotropic medication
12	under joint rules adopted by the Arkansas Psychology Board and the Arkansas
13	State Medical Board under this subchapter as provided in § 17-97-606(b).
14	
15	17-97-605. Conditional prescription certificate.
16	(a) The Arkansas Psychology Board shall grant a conditional
17	prescription certificate to an applicant if the applicant:
18	(1) Holds a current license to practice psychology in this
19	<u>state;</u>
20	(2) Has completed pharmacological training from an institution
21	approved by the Arkansas Psychology Board and the Arkansas State Medical
22	Board or from a provider of continuing education approved by the Arkansas
23	Psychology Board and the Arkansas State Medical Board under joint rules
24	adopted by both boards;
25	(3) Has passed a national certification examination approved by
26	the Arkansas Psychology Board and the Arkansas State Medical Board that
27	tested the applicant's knowledge of pharmacology in the diagnosis, care, and
28	treatment of mental disorders;
29	(4)(A) Within five (5) years immediately preceding the date of
30	application, has successfully completed a post-doctoral master of science
31	degree in clinical psychopharmacology approved by the Arkansas Psychology
32	Board and the Arkansas State Medical Board under joint rules adopted by both
33	boards.
34	(B) The degree under subdivision (a)(4)(A) of this section
35	shall at a minimum include coursework in neuroscience, pharmacology,
36	psychopharmacology, physiology, and appropriate and relevant physical and

1 laboratory assessments; 2 (5)(A) Within five (5) years immediately preceding the date of 3 application, has been certified by the applicant's supervising physician as 4 having successfully completed a supervised and relevant clinical experience 5 in clinical assessment and pathophysiology and an additional supervised 6 practicum treating patients with mental disorders. 7 (B) The practica under subdivision (a)(5)(A) of this 8 section shall have been supervised by a trained physician. 9 (C) The Arkansas Psychology Board and the Arkansas State 10 Medical Board under joint rules adopted by the boards shall determine sufficient practica to competently train the applicant in the treatment of a 11 12 diverse patient population; 13 (6) Possesses malpractice insurance that will cover the 14 applicant during the period the conditional prescription certificate is in 15 effect; and 16 (7) Meets all other requirements, as determined by joint rules 17 adopted by the Arkansas Psychology Board and the Arkansas State Medical 18 Board, for obtaining a conditional prescription certificate. 19 (b) A conditional prescription certificate is valid for four (4) 20 years, at the end of which the holder may apply for renewal of the 21 conditional prescription certificate. 22 (c) A psychologist with a conditional prescription certificate may 23 prescribe psychotropic medication under the supervision of a licensed physician subject to all of the following conditions: 24 25 (1) The psychologist shall continue to hold a current license to 26 practice psychology in this state and continue to maintain malpractice 27 insurance; 28 (2) The psychologist shall inform the Arkansas Psychology Board 29 of the name of the physician under whose supervision the psychologist will 30 prescribe psychotropic medication and promptly inform the Arkansas Psychology 31 Board of any change of the supervising physician; 32 (3)(A) A physician supervising a psychologist prescribing psychotropic medication pursuant to a conditional prescription certificate 33 34 shall be subject to disciplinary action for the acts and omissions of the 35 psychologist while under the physician's supervision. 36 (B) Subdivision (c)(3)(A) of this section does not relieve

1	the psychologist from liability for the psychologist's acts and omissions;

3	(4) Any additional requirements imposed by other rules adopted
4	jointly by the Arkansas Psychology Board and the Arkansas State Medical
5	Board.
6	
7	17-97-606. Prescription certificate.
8	(a) The Arkansas Psychology Board shall grant a prescription
9	certificate to an applicant if the applicant:
10	(1)(A) Possesses a conditional prescription certificate and has
11	successfully completed two (2) years of prescribing psychotropic medication
12	as certified by the supervising licensed physician.
13	(B) An applicant for a prescription certificate who
14	specializes in the psychological care of children, elderly persons, or
15	persons with comorbid psychological conditions shall complete at least one
16	(1) year prescribing psychotropic medications to such populations as
17	certified by the supervising licensed physician;
18	(2) Holds a current license to practice psychology in this
19	<u>state;</u>
20	(3) Possesses malpractice insurance that will cover the
21	applicant as a prescribing psychologist; and
22	(4) Meets all other requirements for obtaining a prescription
23	certificate as determined by rules adopted by the Arkansas Psychology Board
24	and joint rules adopted by the Arkansas Psychology Board and the Arkansas
25	<u>State Medical Board.</u>
26	(b) A psychologist with a prescription certificate may prescribe
27	psychotropic medication under this subchapter if the psychologist:
28	(1) Continues to hold a current license to practice psychology
29	in this state and maintains malpractice insurance;
30	(2) Annually satisfies the continuing education requirements for
31	prescribing psychologists, as determined by the Arkansas Psychology Board,
32	which shall be no fewer than twenty (20) hours each year;
33	(3) Has entered into a collaborative practice agreement with a
34	licensed physician; and
35	(4) Complies with any other rules adopted jointly by the
36	Arkansas Psychology Board and the Arkansas State Medical Board.

2	17-97-607. Prescribing practices.
3	(a)(l) A prescribing psychologist or a psychologist with a conditional
4	prescription certificate may administer and prescribe psychotropic medication
5	within the scope of the psychologist's profession, including the ordering and
6	review of laboratory tests in conjunction with the prescription, for the
7	treatment of mental disorders.
8	(2) The prescribing practices under subdivision (a)(1) of this
9	section shall be governed by joint rules adopted by the Arkansas Psychology
10	Board and the Arkansas State Medical Board.
11	(b) When prescribing psychotropic medication for a patient, the
12	prescribing psychologist or the psychologist with a conditional prescription
13	certificate shall maintain an ongoing collaborative relationship with the
14	licensed physician who oversees the patient's general medical care to ensure
15	that necessary medical examinations are conducted, the psychotropic
16	medication is appropriate for the patient's medical condition, and
17	significant changes in the patient's medical or psychological condition are
18	discussed.
19	(c) A prescription written by a prescribing psychologist or a
20	psychologist with a conditional prescription certificate shall:
21	(1) Be in compliance with applicable state and federal laws;
22	(2) Be identified as issued by the psychologist as "psychologist
23	certified to prescribe"; and
24	(3) Include the psychologist's assigned identification number.
25	(d)(l) A prescribing psychologist or a psychologist with a conditional
26	prescription certificate shall not delegate prescriptive authority to any
27	other person.
28	(2) Records of all prescriptions shall be maintained in patient
29	records.
30	(e)(1) When authorized to prescribe controlled substances, a
31	prescribing psychologist or a psychologist with a conditional prescription
32	certificate shall file with the Arkansas Psychology Board in a timely manner
33	all individual United States Drug Enforcement and Administration registration
34	and numbers.
35	(2) The Arkansas Psychology Board shall maintain current records
36	on every psychologist licensed in this state, including United States Drug

1	Enforcement and Administration registration and numbers.
2	
3	17-97-608. Board duties regarding prescription certificates and
4	conditional prescription certificates.
5	(a)(1) In consultation with the Arkansas State Medical Board, the
6	Arkansas Psychology Board shall adopt rules to implement this subchapter
7	relating to prescribing psychologists.
8	(2) The rules adopted under subdivision (a)(1) of this section
9	shall include without limitation:
10	(A)(i) Procedures to obtain a conditional prescription
11	certificate, a prescription certificate, and a renewal of a conditional
12	prescription certificate and a prescription certificate.
13	(ii) The Arkansas Psychology Board may set
14	reasonable application and renewal fees for a conditional prescription
15	certificate and a prescription certificate;
16	(B) Grounds for the denial, suspension, or revocation of a
17	conditional prescription certificate and a prescription certificate,
18	including a provision for suspension or revocation of a license to practice
19	psychology upon suspension of a conditional prescription certificate and a
20	prescription certificate;
21	(C)(i) The provision of an annual list of psychologists
22	with prescription certificates and psychologists with conditional
23	prescription certificates that contains the information agreed to between the
24	Arkansas Psychology Board and the Arkansas State Medical Board.
25	(ii) The Arkansas Psychology Board shall promptly
26	notify the Arkansas State Medical Board concerning psychologists who are
27	added to or removed from the list; and
28	(D) Any other requirements necessary for the
29	administration of this subchapter.
30	<u>(b)(1) The Arkansas Psychology Board shall appoint a prescribing</u>
31	psychologist rules subcommittee to develop rules for consideration by the
32	Arkansas Psychology Board under subsection (a) of this section.
33	(2) The subcommittee under subdivision (b)(1) of this section
34	shall consist of:
35	(A) One (1) psychologist appointed by the Arkansas
36	Psychology Board;

1	(B) One (1) physician appointed by the Arkansas State
2	Medical Board; and
3	(C) One (1) member of the public appointed by the
4	Secretary of the Department of Health.
