Repeal:	Rule 2 is not necessary. Statutes authorize amendments to the rules as well as authorizing the Commission to adopt additional rules. A.C.A. §11-9-205(a)(1)(A) provides the Arkansas Worker's Compensation Commission is authorized "To make rules and regulations as may be found necessary;". Additionally, A.C.A. §11-9-207(a)(9) provides the Commission full power and authority "To prescribe rules and regulations governing the representation of employees, employers, and the carriers in respect to claims before the commission".

Repeal:	Rule 6 is no longer necessary. Rule 6 provides the requirement for a non-statutory employer, electing to be governed by the statute, to continue until notice to the contrary is filed with the Commission. AWCC "FORM P" is the mechanism to provide notice to employees of worker's compensation coverage by the employer. Previous versions of "FORM P" did not provide the expiration date of the policy. The current version of "FORM P" requires the policy expiration date to be posted. This change provides the notice and protection to non-statutory employees as intended by Rule 6.A.C.A. §11-9-403(b) and §11-9-407 together with the prescribed "FORM P" makes Rule 6 not necessary.

Rule 7 originally contained language to be used for posting such notice. This notice language utilized for posting notice has now been incorporated into "FORM P". As such, Rule 7 is no longer necessary.
