<u>SB91</u>	C. Penzo	TO PROVIDE THAT LOCAL GOVERNMENTAL UNITS SHALL HAVE NO AUTHORITY TO REGULATE OR CONTROL THE AMOUNT CHARGED FOR A RENTAL APPLICATION FEE OR RENTAL DEPOSIT FOR PRIVATE RESIDENTIAL OR COMMERCIAL PROPERTY.

<u>SB271</u>	Crowell	TO AMEND THE LAW CONCERNING A COUNTY CLERK'S CERTIFICATION OF SCHOOL BOARD CANDIDATES TO THE COUNTY BOARD OF ELECTION COMMISSIONERS.
<u>SB297</u>	K. Hammer	TO AMEND THE LAW CONCERNING MUNICIPALITIES CHOOSING TO ELECT COUNCIL MEMBERS; AND TO REQUIRE FILING OF THE ORDINANCE DESCRIBING THE ELECTION OF CITY COUNCIL MEMBERS WITH THE COUNTY CLERK.

<u>SB10</u>	B. King	TO AMEND THE ARKANSAS DATA CENTERS ACT OF 2023; AND TO REGULATE THE IMPACT ON WATER USAGE AND THE ELECTRIC GRID BY BLOCKCHAIN NETWORKS AND DIGITAL ASSET MINING.
<u>SB60</u>	Hill	TO PROHIBIT A DIGITAL ASSET MINING BUSINESS FROM BEING LOCATED WITHIN A THIRTY-MILE RADIUS OF A MILITARY FACILITY; AND TO DECLARE AN EMERGENCY.
