- 1. Arkansas Health Insurance Marketplace Report-(Remove)**
  - a. Frequency: Annually by October 1 to Legislative Council
  - b. Purpose: Describe AID recommendations for assessment or user fee and increases or decreases in the amount of future assessments or user fees and penalties and interest charges for nonpayment of an assessment or user fee charged to participating health insurers.
  - c. Mandated by Law: Yes, Ark. Code Ann. § 23-61-805. However, when AHIM transitioned to AID, AID stopped collecting user fees, and the report became unnecessary.
  - d. Approximate time to prepare: N/a
  - e. Questions ever received on the report? No
- 2. Report on Operations of Arkansas Healthcare Transparency Initiative (Retain)**
  - a. Frequency: Biennial
  - b. Purpose: Report on the operations of the AHTI
  - c. Mandated by Law: Yes, Ark. Code Ann. § 23-61-905
  - d. Approximate time to prepare: Unknown. AID contracts with the Arkansas Center for Health Improvement to prepare this report on our behalf.
  - e. Questions ever received on the report? Not by AID
- 3. Comprehensive Performance Review of Arkansas Workers' Compensation Insurance Plan (Retain)**
  - a. Frequency: Commissioner conducts review at least once every five years (standard exam); Commissioner reports results of review and actions taken to improve plan performance to Legislative Council and House/Senate I and C
  - b. Purpose: Examine each servicing carrier; no "report" document is generated, only examination materials
  - c. Mandated by law: Ark. Code Ann. § 23-67-304
  - d. Approximate time to prepare: 8 hours
  - e. Questions ever received on the report? No
- 4. Annual Review of Arkansas Workers' Compensation Insurance Plan Operations (Remove)**
  - a. Frequency: Annually reported on September 1
  - b. Purpose: Review plan operations to ensure compliance with Arkansas Workers' Compensation Insurance Plan
  - c. Mandated by law: Yes, Ark. Code Ann. § 23-67-313
  - d. Approximate time to prepare: 8 hours
  - e. Questions ever received on the report? No
- 5. "Wendelyn's Craniofacial Law -- Craniofacial Coverage" Report (Remove)**
  - a. Frequency: Biannual report
  - b. Purpose: No purpose stated
  - c. Mandated by law: Yes, Ark. Code Ann. § 23-79-1503 (Act 955 of 2021)
  - d. Approximate time to prepare: Unknown
  - e. Questions ever received on the report? No

**6. Report of the Administrator of the Risk Management Division (Remove)**

- a. Frequency: Annually, however Risk told not to file
- b. Purpose: Report findings and recommendations of the Division to the Governor and Legislative Council
- c. Mandated by Law: Yes, Ark. Code Ann. § 23-61-610. The Risk Division recalls ALC told the Risk Administrator in the early 2000s that this report was no longer needed.

**7. Criminal Investigation Division: Annual Report on Health Insurance Fraud(Remove)**

- a. Frequency: Annually on or before March 1
- b. Purpose: Summarizing the State Insurance Department's activities to investigate and combat health insurance fraud
- c. Mandated by Law: Yes, Ark. Code Ann. § 23-61-116; however, plan to report this material within State Insurance Department Annual Report
- d. Approximate time to prepare: Unknown
- e. Questions ever received on the report? No

**8. Other Reports: State Insurance Department Annual Report (provided to Secretary of Commerce; not required to file with General Assembly or its committees) (Retain)**

- a. Frequency: Annually, as early in calendar year as possible
- b. Purpose: Names of authorized and admitted insurers along with financial condition, total receipts and expenses of Department previous year
- c. Mandated by law: Yes, Ark. Code Ann. § 23-61-112 requires this report be filed with the Secretary; not General Assembly or its committees.
- d. Approximate time to prepare: Four to six weeks
