18	Subtitle
19	TO PROVIDE TRANSPARENCY AND
20	ACCOUNTABILITY FOR PUBLIC UTILITIES; AND
21	TO REQUIRE CERTAIN PUBLIC UTILITIES TO
22	REPORT TO THE LEGISLATIVE COUNCIL.
23	
24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. DO NOT CODIFY. Legislative findings and intent.
27	(a) The General Assembly finds that:
28	(1) Arkansas residents continue to face economic hardships due
29	to spiraling inflation;
30	(2) Costs continue to rise for public utility ratepayers for
31	both electricity and natural gas, stretching family budgets to pay for
32	critical services in this state;
33	(3) Electric rates have increased four (4) times for many
34	Arkansas ratepayers since 2021;
35	(4) Natural gas rates increased by more than twenty-three
36	percent (23%) for Summit Utilities ratepayers in 2024;

1	(5) Public utilities must be good stewards of public utility
2	ratepayer funds and should be transparent with how public utility ratepayer
3	funds are spent; and
4	(6) A utility owned by a governmental entity is mandated to
5	operate with transparency under the Freedom of Information Act of 1967, § 25-
6	<u>19-101 et seq.</u>
7	(b) It is the intent of the General Assembly that Arkansas takes
8	responsibility to ensure public utility rates are established with full
9	transparency and accountability.
10	
11	SECTION 2. Arkansas Code Title 23, Chapter 3, is amended to add an
12	additional subchapter to read as follows:
13	
14	<u>Subchapter 8 - Transparency and Accountability of Public Utilities</u>
15	
16	23-3-801. Definitions.
17	As used in this subchapter:
18	(1)(A) "Advertising" means the act of publishing, disseminating,
19	soliciting, or circulating written, online, video, or audio communication
20	intended to induce a person to patronize a product, service, business, or
21	industry or to promote a business's brand.
22	(B) "Advertising" includes without limitation the act of:
23	(i) Otherwise emphasizing desirable qualities about
24	a product, service, business, or industry; or
25	(ii) Influencing public opinion with respect to
26	legislative, administrative, or electoral matters.
27	(C) "Advertising" does not include public communication:
28	(i) Required by law, rule, or order;
29	(ii) The primary purpose of which is to communicate:
30	(a) Service interruptions, safety measures, or
31	emergency conditions; or
32	(b) Employment opportunities with a public
33	utility; or
34	(iii) Directly related to a program approved by the
35	Arkansas Public Service Commission regarding income-based service, special
36	rates, or energy conservation.

1	(D) "Advertising" includes a communication if any portion
2	of the communication is "advertising" as defined in this section;
3	(2) "Compensation" means salary, bonus, benefits, or other
4	consideration of any value;
5	(3) "Covered business unit" means a division, department, or
6	other organizational employee group within a public utility that performs
7	activities described under this subchapter;
8	(4) "Electric utility" means a public utility, an investor-owned
9	utility, an electric cooperative, or any private power supplier or marketer
10	that is engaged in the business of supplying electrical energy to the
11	ultimate consumer or any customer classes within this state;
12	(5) "Expense" means any payment, expenditure, compensation, or
13	costs;
14	(6) "Gas utility" means a person, or any combination of persons,
15	including a lessee, trustee, or receiver of a utility that:
16	(A) Owns or operates, for compensation in this state,
17	equipment or facilities for storing, transmitting, distributing, selling, or
18	furnishing natural gas to or for the public at retail; and
19	(B) Is regulated by the commission;
20	(7) "Governmental utility" means a utility that is required to
21	make its records available for inspection and copy under the Freedom of
22	Information Act of 1967, § 25-19-101 et seq.;
23	(8)(A) "Political influence activity" means an expense for the
24	purpose of directly or indirectly influencing the possible:
25	(i) Adoption, repeal, or modification of federal,
26	state, or local rules, regulations, legislation, or ordinances;
27	(ii) Election, recall, appointment, or removal of a
28	<pre>public official;</pre>
29	(iii) Adoption or rejection of initiatives or
30	referenda;
31	(iv) Approval, modification, or revocation of a
32	<pre>public utility franchise;</pre>
33	(v) Public opinion with respect to federal, state,
34	or local:
35	(a) Adoption, repeal, or modification of
36	rules regulations legislation or ordinances.

1	(b) Election, recall, appointment, or removal
2	of a public official;
3	(c) Adoption or rejection of initiatives or
4	referenda;
5	(d) Approval, modification, or revocation of a
6	public utility franchise; or
7	(e) Public utility rate setting; or
8	(vi) Decisions of federal, state, or local
9	government officials.
10	(B) "Political influence activity" includes an activity
11	undertaken in support of activities listed in subdivisions (8)(A)(i) $-$ (vi)
12	of this section, including research, analysis, preparation, or planning or
13	any other related costs identified by the commission.
14	(C) "Political influence activity" does not include:
15	(i) An appearance before the commission when the
16	public utility is the applicant in an uncontested proceeding; or
17	(ii) An appearance before a legislative committee,
18	the commission, or a state agency when the public utility's participation has
19	been specifically requested in writing by the chair of the legislative
20	committee, chair of the commission, or head of the state agency;
21	(9)(A) "Public utility" means:
22	(i) An electric utility; or
23	(ii) A gas utility.
24	(B) "Public utility" does not include a governmental
25	utility; and
26	(10) "Public utility affiliate" means an entity that is related
27	to the public utility as a subsidiary, parent, or sibling corporation,
28	including without limitation by shareholding or other means of control.
29	
30	23-3-802. Public utility rate transparency and disclosure — Political
31	and investor-related expenses.
32	(a)(1) On or before January 1, 2026, and annually thereafter, each
33	public utility with more than three thousand (3,000) ratepayers shall provide
34	a report to the Legislative Council.
35	(2) The report required under subdivision (a)(1) of this section
36	shall include the expenses from the previous calendar year of any direct or

1	indirect costs that are recovered through rates of a public utility for:
2	(A) Membership, dues, sponsorships, or contributions to a
3	trade association if any portion of those contributions supports political
4	influence activities or advertising;
5	(B) Charitable giving, including contributions to
6	organizations qualified under 26 U.S.C. § 501(c)(3) or 26 U.S.C. § 501(c)(4),
7	as they existed on January 1, 2025, and any expenses related to charitable
8	giving;
9	(C) Political influence activities;
10	(D) Advertising;
11	(E) Any compensation for an employee of a public utility,
12	if any portion of that compensation is used for attempts by the employee to
13	influence the decision of federal, state, or local government officials;
14	(F) Contributions to a political candidate, political
15	party, campaign committee, issue committee, or independent expenditure
16	committee or other political expenses;
17	(G) Litigation regarding existing or proposed federal,
18	state, or local rules, regulations, legislation, or ordinances;
19	(H) Any costs, including marketing, administration,
20	customer service, or other costs, for products or services not regulated by
21	the Arkansas Public Service Commission;
22	(I) Penalties or fines, including tax penalties or fines,
23	issued against a public utility;
24	(J) Travel, lodging, or food and beverage expenses for a
25	public utility's board of directors and officers or the board of directors
26	and officers of a public utility affiliate;
27	(K) Any owned, leased, or chartered aircraft for the
28	public utility's board of directors and officers or the board of directors
29	and officers of a public utility affiliate;
30	(L) Investor relations; and
31	(M) Annual compensation that is in excess of the current
32	annual compensation of the Governor for an individual, including an employee
33	of the public utility, a member of the public utility's board of directors or
34	officers, or a member of the board of directors or officers of a public
35	utility affiliate.
36	(b) The report required under subdivision (a)(1) of this section shall

1	<pre>include without limitation:</pre>
2	(1) An itemized list of all expenses associated with activities
3	described under subdivision (a)(2) of this section, including any expenses
4	paid to:
5	(A) A vendor, including a separate line item for each
6	payment to a vendor for activities described under subdivision (a)(2) of this
7	section;
8	(B) A trade association, if any portion of those expenses
9	supports political influence activities or advertising;
10	(C) An organization qualified under 26 U.S.C. § 501(c)(3)
11	or 26 U.S.C. § 501(c)(4), as they existed on January 1, 2025;
12	(D)(i) A public utility employee in the form of
13	compensation or reimbursement.
14	(ii) For each employee listed under subdivision
15	(b)(l)(D)(i) of this section, the list shall include:
16	(a) The employee's job title;
17	(b) A job description sufficient to describe
18	the employee's responsibilities;
19	(c) Each activity described under subdivision
20	(a)(2) of this section in which the employee engaged;
21	(d) A description sufficient to describe the
22	employee's nature of that work;
23	(e) The total annual compensation for the
24	<pre>employee;</pre>
25	(f) The percentage of annual compensation paid
26	for work associated with the activities described under subdivision (a)(2) of
27	this section;
28	(g) The percentage of annual compensation
29	recoverable from ratepayers; and
30	(h) All uniform system of account codes to
31	which compensation was recorded for the employee; and
32	(E) Public utility affiliates, including a separate line
33	item for each payment to a public utility affiliate for activities described
34	under subdivision (a)(2) of this section;
35	(2) A list of all expenses paid to vendors; and
36	(3)(A) A list of covered business units of the public utility.

1	(B) For each covered business unit, the public utility
2	shall include a list of employees who work in that covered business unit.
3	(C) For each employee, the public utility shall include:
4	(i) The employee's job title;
5	(ii) A job description sufficient to describe the
6	employee's responsibilities; and
7	(iii) Whether or not the employee conducted an
8	activity that is described under subdivision (a)(2) of this section.
9	(c)(1) For an employee who conducted an activity described under
10	subdivision (a)(2) of this section, the report required under subdivision
11	(a)(1) of this section shall list:
12	(A) Each activity described in subdivision (a)(2) of this
13	section in which the employee engaged;
14	(B) A description sufficient to describe the nature of
15	that work;
16	(C) The total annual compensation paid for work associated
17	with the activities described under subdivision (a)(2) of this section;
18	(D) The percentage of annual compensation recoverable from
19	ratepayers; and
20	(E) All uniform system of account codes to which
21	compensation was recorded for the employee.
22	(2) An itemized list required under subdivision (c)(l) of this
23	section shall include:
24	(A) The billing amount;
25	(B) The billing date;
26	(C) The identity of the payee;
27	(D) An explanation of the expense sufficient to describe
28	its purpose; and
29	(E) Any other itemized information deemed relevant by the
30	Legislative Council.
