<a href="#">SJR2</a>	B. King	A CONSTITUTIONAL AMENDMENT TO CREATE THE ARKANSAS APPORTIONMENT COMMISSION TO APPORTION DISTRICTS FOR THE HOUSE OF REPRESENTATIVES, THE SENATE, AND THE UNITED STATES HOUSE OF REPRESENTATIVES.
