Consideration to Approve the April 22, 2024, and April 23, 2024, Meeting Minutes [Exhibits B1-B2] Representative Ray made a motion to approve the minutes, seconded by Representative Evans, and the motion carried.

**Discussion of Pulaski County Detention Center and Netflix Docuseries** *Unlocked: A Jail Experiment* Eric S. Higgins, Sheriff, Pulaski County Sheriff's Office (PCSO), gave a discussion regarding the re-entry program within the Pulaski County Detention Center (PCDC). Sheriff Higgins emphasized that he personally did not reach out to any production company to film the docuseries, and he stated that the purpose of the re-entry program was to reduce recidivism for detainees in Pulaski County.

Barry Hyde, County Judge, Pulaski County, expressed his lack of awareness regarding the Netflix docuseries until the trailer was released. He stated that the contract between Lucky 8 Productions and the PCSO was illegal on the grounds that it had not been signed by a county judge.

Sterling Penix, Coordinator, Commission on Law Enforcement Standards and Training, Criminal Detention Facilities Review Committees, Arkansas Department of Public Safety (DPS), gave testimony regarding Sheriff Higgins's policies on the housing and monitoring of PCDC inmates. Upon his review of the docuseries, he expressed that there were some concerns regarding the PCDC's compliance with the jail standards set forth by DPS.
