22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. DO NOT CODIFY. Legislative findings.
25	The General Assembly finds that:
26	(1) The childcare needs in Arkansas necessitate the enhancement
27	of accessible childcare options for families, particularly in rural and
28	small-town areas;
29	(2) Exempting licensed childcare homes from restrictive zoning
30	regulations would facilitate the growth of small businesses, contributing to
31	local economies and community vitality; and
32	(3) Successful outcomes in communities such as Gentry and
33	Gravette demonstrate that support for childcare initiatives can lead to an
34	increase in available slots for children without negatively impacting local
35	resources.

1	SECTION 2. Arkansas Code § 20-78-229(b), concerning compliance with local regulations
2	under the Childcare Facility Licensing Act, is amended to read as follows:
3	(b)(1) The Except as provided in subsection (f) of this section, the Division of Child Care and
4	Early Childhood Education shall require any childcare facility seeking licensure under this
5	subchapter to comply with applicable zoning and land use development regulations of the
6	municipality and county where the childcare facility is located.
7	(2) Failure to comply with applicable zoning and land use regulations is grounds for
8	the denial of a license of a childcare facility.
9	
10	SECTION 3. Arkansas Code § 20-78-229 is amended to add an additional
11	subsection to read as follows:
12	(f)(l) As used in this subsection, "licensure" means the process
13	through which the Division of Child Care and Early Childhood Education grants
14	permission to operate a childcare family home under this subchapter.
15	(2)(A) Except as provided in subdivision (f)(3) of this section,
16	a childcare family home that is licensed or seeking licensure under this
17	subchapter is exempt from local zoning ordinances that restrict the operation
18	of a childcare family home.
19	(B) An exemption from local zoning ordinances under
20	subdivision (f)(2) of this section applies to all residential properties
21	within corporate limits of a municipality.
22	(3) A municipality shall enforce existing health and safety
23	regulations applicable to all childcare facilities to ensure community
24	standards are upheld.
25	(4) The Division of Child Care and Early Childhood Education
26	shall provide guidance and resources to aspiring childcare providers to
27	ensure adherence to essential health, safety, and educational standards and
28	this subsection.
29	
30	SECTION 4. DO NOT CODIFY. EMERGENCY CLAUSE. It is found and
31	determined by the General Assembly of the State of Arkansas that there is a
32	need for accessible childcare options throughout the state; that rural
33	communities cannot increase childcare options due to restrictive zoning
34	regulations of the local government; and that this act is immediately
35	necessary because increasing access to affordable childcare is needed to
36	preserve public health, peace, and safety. Therefore, an emergency is

1	declared to exist, and this act being immediately necessary for the
2	preservation of the public peace, health, and safety shall become effective
3	on:
4	(1) The date of its approval by the Governor;
5	(2) If the bill is neither approved nor vetoed by the Governor,
6	the expiration of the period of time during which the Governor may veto the
7	<pre>bill; or</pre>
8	(3) If the bill is vetoed by the Governor and the veto is
9	overridden, the date the last house overrides the veto.
