The Crimes Against Children Division operates with one (1) Major, one (1) Investigations Administrator, one (1) Admin Analyst, three (3) Admin Specialist II, eleven (11) Area Managers, seventy-One (71) Investigators, one (1) Hotline Administrator, five (5) Hotline Supervisors and Twenty - seven (27) Hotline Operators.

Child Abuse Hot Line operators in the Crimes Against Children Division (CACD) of the Arkansas State Police received 67,987 referrals in the year 2025. Of these referrals, 37,986 were accepted as legally valid allegations of abuse or neglect. They were assigned for investigation to CACD investigators or to the Arkansas Department of Human Services' (DHS) Division of Children and Family Services (DCFS).

Attached you will find the CACD Child Abuse Hotline Referral Statistics Report for 2025. There was a total of 6804 Child Abuse Hotline Referrals which contained 7612 maltreatment allegations – 4052 priority one allegations and 3560 priority two allegations.

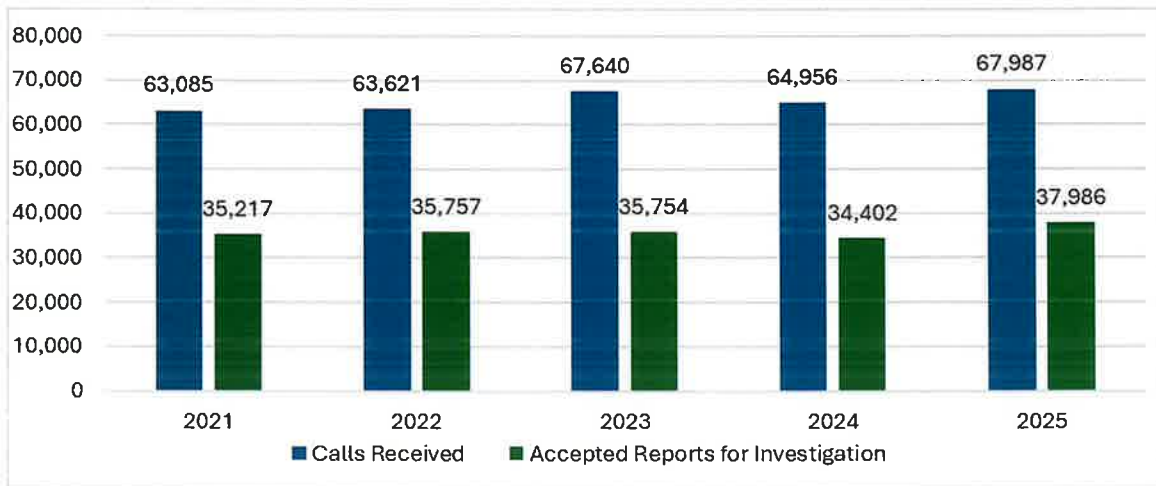

In 2025, the Hotline received 67,987 calls, which were 3,031 more than 2024.

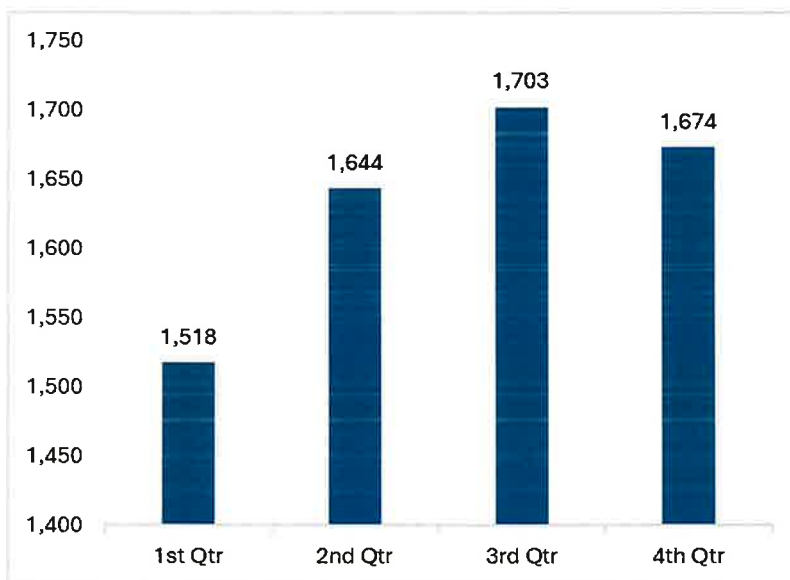


In 2025, the number of accepted reports for investigations increased by 3,584.

The referrals accepted by the Hotline are divided into categories for investigation, pursuant to an agreement with DHS. This resulted in **6,539** referrals being investigated by the Investigation Unit of CACD in 2025. Each referral may contain multiple allegations.

Total Priority 1 Allegations by type for 2025

- Abandonment - 11
- Abuse - 1208
- Neglect - 504
- Sexual Abuse - 2189
- Sexual Exploitation - 120
- Death – 21

Of the total number of Priority 1 allegations, **4,053** (57%) involved sexual related offenses. CACD investigators closed **5,933** referrals in 2025. Of the closed referrals, **1,641** (28%) were found to be 'true'.

The investigative determination of 'true' means there was a preponderance of evidence that indicated the allegation(s) was true. An 'unsubstantiated' finding means the evidence was insufficient to support the allegation(s). Investigations closed with a determination of 'true' were reported to the appropriate prosecuting attorney.
