**SUBJECT: COLLECTION AND DISTRIBUTION OF GENERAL AND SPECIAL REVENUES - 2019-2020**

Attached is the 2019-2020 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2019-2020 fiscal year. In summary, Gross General Revenue collections of approximately \$6,982.6 million decreased \$256.0 million or 3.54% below the \$7,238.6 million collected in fiscal year 2018-19. Adjusted Net General Revenues available for distribution of \$5,753.4 million decreased \$168 million or 2.84% below the \$5,921.4 million available for distribution in fiscal year 2018-19. Gross Special Revenues of \$2,342.4 million increased \$49.4 million or 2.15% more than the \$2,293.0 million collected in fiscal year 2018-19.
