SENATE BILL

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED §6-63-305(b) TO
9 AUTHORIZE PROVISIONAL POSITIONS FOR TECHNICAL COLLEGES;
10 AND FOR OTHER PURPOSES."

13 "AN ACT TO AUTHORIZE PROVISIONAL POSITIONS FOR TECHNICAL
14 COLLEGES."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Arkansas Code §6-63-305(b) is amended to read as follows:

19 "(b) The following maximum number of new additional positions is
20 established for the biennium for the following institutions of higher
21 education, at salary rates not to exceed the salary rate of comparable
22 positions established in the regular salaries section of the biennial
23 appropriations act for operations for each institution:

31 SECTION 2. All provisions of this act of a general and permanent nature
32 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
33 Revision Commission shall incorporate the same in the Code.

35 SECTION 3. If any provision of this act or the application thereof to

1 any person or circumstance is held invalid, such invalidity shall not affect
2 other provisions or applications of the act which can be given effect without
3 the invalid provision or application, and to this end the provisions of this
4 act are declared to be severable.

6 SECTION 4. All laws and parts of laws in conflict with this act are
7 hereby repealed.
