27	SECTION 5. SPECIAL LANGUAGE. <u>Arkansas</u>	Code A	nnotated 26-	58-124(b)(2)(A)(ii)

is hereby amended to read as follows: "(ii) The next three hundred fifty 28 29 thousand dollars (\$350,000) or so much thereof as may be collected in severance taxes, penalties, and costs on timber and timber products, over and 30 31 above the amount distributed to the State Forestry Fund during each fiscal year as provided in subdivision (b)(2)(A)(i) of this section, shall be 32 distributed and credited to the University of Arkansas at Monticello Fund. 33 The University of Arkansas at Monticello may transfer from General Revenue to 34 cash funds any timber severance tax funds as provided in Arkansas Code 26-58-35 <u>124 subdivision (b)(2)(A)(ii)</u>, to be set aside therein to be used solely and 36

5 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made 6 7 available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures 8 9 Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education Expenditures Restrictions Act, or their 10 successors, and other fiscal control laws of this State, where applicable, and 11 12 regulations promulgated by the Department of Finance and Administration, as 13 authorized by law, shall be strictly complied with in disbursement of said 14 funds.

SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly 16 17 that any funds disbursed under the authority of the appropriations contained 18 in this act shall be in compliance with the stated reasons for which this act 19 was adopted, as evidenced by the Agency Requests, Executive Recommendations 20 and Legislative Recommendations contained in the budget manuals prepared by 21 the Department of Finance and Administration, letters, or summarized oral 22 testimony in the official minutes of the Arkansas Legislative Council or Joint 23 Budget Committee which relate to its passage and adoption.

25 SECTION 8. CODE. All provisions of this Act of a general and permanent 26 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 27 Code Revision Commission shall incorporate the same in the Code.

SECTION 9. SEVERABILITY. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

35 SECTION 10. GENERAL REPEALER. All laws and parts of laws in conflict with 36 this act are hereby repealed.

2	SECTION 11. EMERGENCY CLAUSE. It is hereby found and determined by the
3	Eighty-second General Assembly, that the Constitution of the State of Arkansas
4	prohibits the appropriation of funds for more than a two (2) year period; that
5	the effectiveness of this Act on July 1, 1999 is essential to the operation of
6	the agency for which the appropriations in this Act are provided, and that in
7	the event of an extension of the Regular Session, the delay in the effective
8	date of this Act beyond July 1, 1999 could work irreparable harm upon the
9	proper administration and provision of essential governmental programs.
10	Therefore, an emergency is hereby declared to exist and this Act being
11	necessary for the immediate preservation of the public peace, health and
12	safety shall be in full force and effect from and after July 1, 1999.
