Of the total amount appropriated for Technology Grants 12 each fiscal year, an amount of not less than one million dollars (\$1,000,000) or eighteen percent (18%), whichever is greater each fiscal year, shall be 13 14 awarded through a grant or professional services contract for EAST 15 infrastructure personal services and operating expenses. The EAST 16 infrastructure grant or contract for personal services and operating expenses 17 shall be awarded to an entity that has personnel or experience, or both, in implementing the EAST Initiative. 18 19 The provisions of this section shall be in effect only from July 1, 2003 20 through June 30, 2005. 21 22 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 23 24 PRIORITIZATION OF FUNDING. The State Board of Education shall give first 25 priority to allocating funding for those line-items contained in Section 1 of 26 this Act that further the State's goal of maintaining equitable funding of 27 students in the public schools of this State. Of the total appropriation authorized by this Act for 34 35 Technology Grants the Department of Education shall make available one hundred eighty seven thousand five hundred seventy five dollars (\$187,575) 36

9 SECTION 27. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained 10 11 in this act shall be in compliance with the stated reasons for which this act 12 was adopted, as evidenced by the Agency Requests, Executive Recommendations 13 and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral 14 15 testimony in the official minutes of the Arkansas Legislative Council or 16 Joint Budget Committee which relate to its passage and adoption.

SECTION 28. EMERGENCY CLAUSE. It is found and determined by the General 18 Assembly, that the Constitution of the State of Arkansas prohibits the 19 20 appropriation of funds for more than a two (2) year period; that the 21 effectiveness of this Act on July 1, 2003 is essential to the operation of 22 the agency for which the appropriations in this Act are provided, and that 23 the General Assembly recognizes the important contribution to education made by the Pygmalion Commission on Nontraditional Education, and that recognizing 24 and identifying how the educational system is failing a child early enough to 25 26 provide meaningful intervention is necessary to improve the educational 27 outcomes for at-risk students, and the Pygmalion Commission shall expire on 28 June 30, 2003 unless the General Assembly continues the Commission by further 29 act, and that Section 24 of this Act shall become effective immediately upon 30 its passage and approval, and that the General Assembly further recognizes the financial hardships placed on school district resources if the required 31 32 salary increase authorized by The Educator Compensation Act of 2001 is to 33 continue, and that Section 25 of this Act shall become effective immediately 34 upon its passage and approval due to the economic downturn of state revenues 35 and insufficient resources to provide school districts with sufficient funds to implement the required salary increase, and that in the event of an 36

1	extension of the Regular Session, the delay in the effective date of the
2	remaining sections of this Act beyond July 1, 2003, could work irreparable
3	harm upon the proper administration and provision of essential governmental
4	programs. Therefore, an emergency is declared to exist and this act being
