23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. APPROPRIATION. There is hereby appropriated, to the Department
26 of Education, to be payable from the Department of Education Public School
27 Fund Account, for grants and aids to local school districts and special
28 programs of the Department of Education for the biennial period ending June
29 30, 2005, the following:

12 SECTION 2. REGULAR SALARIES - APSCN. There is hereby established for the
 13 Department of Education - Arkansas Public School Computer Network for the
 14 2003-2005 biennium, the following maximum number of regular employees whose
 15 salaries shall be governed by the provisions of the Uniform Classification
 16 and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor,
 17 and all laws amendatory thereto. Provided, however, that any position to
 18 which a specific maximum annual salary is set out herein in dollars, shall be
 19 exempt from the provisions of said Uniform Classification and Compensation
 20 Act. All persons occupying positions authorized herein are hereby governed
 21 by the provisions of the Regular Salaries Procedures and Restrictions Act
 22 (Arkansas Code §21-5-101), or its successor.

27 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MATH &
 29 SCIENCE SCHOOL FUND TRANSFER. Any funds which remain in the Department of
 30 Education Public School Fund Account or the Public School Fund for the
 31 Department of Education - Arkansas School for Mathematics and Sciences at the
 32 end of a fiscal year shall be transferred by the Chief Fiscal Officer of the
 33 State to the General Improvement Fund or its successor fund or fund accounts,
 34 there to be used exclusively to provide additional funding for appropriations
 35 for the Department of Education - Arkansas School for Mathematics and
 36 Sciences which are made payable from the General Improvement Fund or its

1 successor fund or fund accounts.

2 The provisions of this section shall be in effect only from July 1, 2003
3 through June 30, 2005.

4
5 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GRANTS TO
7 SCHOOL DISTRICTS. For the purposes of distributing the Grants To School
8 Districts appropriation in Section 1 of this Act, "school district" means a
9 school district which contracts with a school district in an adjoining state
10 for the education of some of the pupils within the Arkansas school district
11 because the portion of the school district wherein such pupils live is
12 completely separated from the remainder of the school district by a reservoir
13 covering at least 12,000 acres at normal water level, and where to attend
14 school in their own district, the pupils of said portion would be required to
15 travel or to be transported a distance (measured by the nearest highway or
16 road route) of more than 35 miles round trip and pass through another school
17 district or districts. The Department of Education shall distribute the
18 monies appropriated for Grants to School Districts in Section 1 of this Act
19 to such school districts as reimbursement for expenses incurred in educating
20 the pupils residing in the separated portion of the school district. Such
21 school districts shall file a request for reimbursement with the Department
22 of Education and provide the Department of Education with such documentation
23 as is deemed necessary.

24 The provisions of this section shall be in effect only from ~~July 1, 2001~~
25 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

26
27 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
29 EDUCATION SERVICES. The funds appropriated in the line item "Special
30 Education Services" in Section 1 of this Act shall be used to provide
31 extended year summer programs for handicapped students in need of such
32 services, to provide special education services to foster children who are
33 wards of the State, and to provide funds for the payment of salaries of
34 special education supervisors. The Department of Education shall distribute
35 such funds in the manner necessary to carry out the intent of this Section.

36 The provisions of this section shall be in effect only from ~~July 1, 2001~~

1 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

2
3 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
5 RETIREMENT MATCHING. Beginning with the 1996-97 school year, Local School
6 Districts shall pay the teacher retirement employer contribution rate for any
7 eligible employee in accordance with rules and regulations established by the
8 Teacher Retirement Board of Directors. The appropriation contained herein for
9 Teacher Retirement Matching each fiscal year shall be used to provide the
10 employer matching for employees of the Cooperative Education Services Areas,
11 Vocational Centers, ~~Model Vocational—Technical Education Resource Center~~,
12 Arkansas Easter Seals and the school operated by the Department of
13 Correction.

14 The provisions of this section shall be in effect only from ~~July 1, 2001~~
15 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

16
17 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HEALTH
19 INSURANCE. Beginning with the 1996-97 school year, Local School Districts
20 shall pay no less than the health insurance contribution rate established by
21 ~~the State Board of Education~~ Arkansas Code 6-17-1117 for each eligible
22 employee electing to participate in the Public School Employee Health
23 Insurance Program. The appropriation contained herein for Public School
24 Employee Insurance each fiscal year shall be used to provide the state
25 contribution for insurance premiums for employees of the Cooperative
26 Education Services Areas, Vocational Centers, ~~Model Vocational—Technical~~
27 ~~Education Resource Center~~ and the school operated by the Department of
28 Correction who participate in the Arkansas Public School Life and Health
29 Insurance Program.

30 The provisions of this section shall be in effect only from ~~July 1, 2001~~
31 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

32
33 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PULASKI
35 COUNTY DESEGREGATION. (A) For the fiscal year ending ~~June 30, 2002~~ June 30,
36 2004, the Department of Education shall from time to time as needed, certify

1 to the State Treasurer and the Chief Fiscal Officer of the State, the amount
2 of funds disbursed for desegregation expenses under the "Pulaski County
3 School Desegregation Settlement Agreement." Upon the receipt of such
4 certification, the State Treasurer, after making those deductions as set out
5 in Arkansas Code 19-5-202(b)(2)(B), shall also deduct up to, but not to
6 exceed in total for fiscal year ~~2001-2002~~ 2003-04 the sum of \$32,800,000 from
7 the net general revenues and transfer this amount to the Department of
8 Education Public School Fund Account.

9 (B) For the fiscal year ending ~~June 30, 2003~~ June 30, 2005, the Department of
10 Education shall from time to time as needed, certify to the State Treasurer
11 and the Chief Fiscal Office of the State, the amount of funds disbursed for
12 desegregation expenses under the "Pulaski County School Desegregation
13 Settlement Agreement." Upon the receipt of such certification, the State
14 Treasurer, after making those deductions as set out in Arkansas Code 19-5-
15 202(b)(2)(B), shall also deduct up to, but not to exceed in total for fiscal
16 year ~~2002-2003~~ 2004-05 the sum of \$32,800,000 from the net general revenues
17 and transfer this amount to the Department of Education Public School Fund
18 Account.

19 The provisions of this section shall be in effect only from ~~July 1, 2001~~
20 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

21
22 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
24 CONSOLIDATION INCENTIVE. The appropriation contained herein for Consolidation
25 Incentive shall be allocated in accordance with rules and regulations
26 established by the State Board of Education.

27 The provisions of this section shall be in effect only from ~~July 1, 2001~~
28 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

29
30 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
32 RESIDENTIAL CENTERS/JUVENILE DETENTION. The funds appropriated herein for
33 Residential Centers/Juvenile Detention shall be allocated in accordance with
34 rules and regulations established by the State Board of Education.

35 The provisions of this section shall be in effect only from ~~July 1, 2001~~
36 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

1
2 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
4 AUTHORITY. The Director of the Department of Education, with the approval of
5 the Chief Fiscal Officer and after approval by the Arkansas Legislative
6 Council or Joint Budget Committee, is hereby authorized to request necessary
7 appropriation transfers and any other budget related adjustments necessary.
8 Determining the maximum number of employees and the maximum amount of
9 appropriation and general revenue funding for a state agency each fiscal year
10 is the prerogative of the General Assembly. This is usually accomplished by
11 delineating such maximums in the appropriation act(s) for a state agency and
12 the general revenue allocations authorized for each fund and fund account by
13 amendment to the Revenue Stabilization law. Further, the General Assembly
14 has determined that the Department of Education may operate more efficiently
15 if some flexibility is provided to the Director of the Department of
16 Education authorizing broad powers under the Transfer Authority provision
17 herein. Therefore, it is both necessary and appropriate that the General
18 Assembly maintain oversight by requiring prior approval of the Legislative
19 Council or Joint Budget Committee as provided by this section. The
20 requirement of approval by the Legislative Council or Joint Budget Committee
21 is not a severable part of this section. If the requirement of approval by
22 the Legislative Council or Joint Budget Committee is ruled unconstitutional
23 by a court jurisdiction, this entire section is void.

24 The provisions of this section shall be in effect only from ~~July 1, 2001~~
25 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

27 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

29 COMPENSATION PURCHASE. The appropriation and funds authorized herein for
30 Purchase of Workers' Compensation Coverage by School Districts and Education
31 Service Cooperatives shall be distributed proportionally by the Department of
32 Education to each of the various school districts based on each school
33 district's average daily membership (ADM) the previous year and to each of
34 the state's education service cooperatives in an amount equal to 50% of the
35 amount each cooperative expended for that purpose the previous year.

36 The provisions of this section shall be in effect only from ~~July 1, 2001~~

8 *Education Public School Fund Account to the University of Arkansas at Little*
9 *Rock Fund, specifically to provide funding for the Arkansas/STRIVE Program.*
10 *The total amount of funds transferred each fiscal year pursuant to this*
11 *section shall not be subject to any indirect costs by the University of*
12 *Arkansas at Little Rock.*

13 *The provisions of this section shall be in effect only from ~~July 1, 2001~~*

18 *74 RULES AND REGULATIONS. Due to pending public school finance litigation,*
19 *before any rules and regulations pursuant to the implementation of Amendment*
20 *74 to the Arkansas Constitution are reviewed by the Administrative Rules and*
21 *Regulations Committee of the Arkansas Legislative Council and adopted by the*
22 *Department of Education, such proposed rules and regulations shall be*
23 *reviewed by the Litigation Reports Oversight Committee of the Arkansas*
24 *Legislative Council.*

25 *The provisions of this section shall be in effect only from ~~July 1, 2001~~*
26 *July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.*

27
28 *SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
29 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.*
30 *ASSESSMENT/END OF LEVEL TESTING. Of the total amount appropriated for*
31 *Assessment/End-of-Level Testing for each fiscal year of the ~~2001-2003~~ 2003-*
32 *2005 biennium, up to \$500,000 may be authorized by the Director of the*
33 *Department of Education to be used to provide staff development training for*
34 *educational cooperatives, school districts, and for Department of Education*
35 *staff on such content areas as test interpretation, goal setting, educational*
36 *plan development, curriculum development, instructional strategies, classroom*

1 management and for evaluation procedures.

2 The provisions of this section shall be in effect only from ~~July 1, 2001~~
3 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

4
5 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. AETN
7 DOCUMENTED QUIZ BOWL COSTS. Of the total amount of appropriation and funds
8 authorized herein to the Department of Education - for the Quiz Bowl each
9 fiscal year, an amount not to exceed 40% each fiscal year may be made
10 available to the Department of Education - Educational Television Division
11 for its documented costs associated with the Quiz Bowl.

12 The provisions of this section shall be in effect only from ~~July 1, 2001~~
13 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

14
15 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OPEN
17 ENROLLMENT CHARTER SCHOOL EVALUATION. The Department of Education is hereby
18 authorized to utilize a portion of the appropriation and funds authorized
19 herein for Open Enrollment Charter Schools for costs associated with the
20 evaluation of Open Enrollment Charter Schools.

21 The provisions of this section shall be in effect only from ~~July 1, 2001~~
22 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

23
24 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
26 INTERVENTION BLOCK GRANTS FUNDING RESTRICTION. *The Department of Education*
27 shall make available from the Intervention Block Grants appropriation
28 authorized by this Act, one hundred thousand dollars (\$100,000) each fiscal
29 year for the annual expenses of the Quiz Bowl, thirteen thousand five hundred
30 dollars (\$13,500) each fiscal year for Odyssey of the Mind for grants up to
31 \$1,000 each for students and chaperones, thirteen thousand five hundred
32 dollars (\$13,500) each fiscal year for Destination Imagination, and five
33 thousand dollars (\$5,000) each fiscal year for the State History Day
34 Competition. The Department of Education shall allocate General Revenue
35 funding totaling no less than one hundred thirty two thousand dollars
36 (\$132,000) each fiscal year from the Department of Education Public School

1 Fund Account to support the annual expenses of the Quiz Bowl, the Odyssey of
2 the Mind for grants up to \$1,000 each for students and chaperones,
3 Destination Imagination, and the State History Day Competition. The
4 Department shall either expend or have committed for expenditure the monies
5 allocated for the Quiz Bowl, Odyssey of the Mind, Destination Imagination,
6 and the State History Day Competition as authorized herein in order to
7 fulfill the provisions of this section.

8
9 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EAST
11 FUNDING PROVISION. Of the total amount appropriated for Technology Grants
12 each fiscal year, an amount of not less than one million dollars (\$1,000,000)
13 or eighteen percent (18%), whichever is greater each fiscal year, shall be
14 awarded through a grant or professional services contract for EAST
15 infrastructure personal services and operating expenses. The EAST
16 infrastructure grant or contract for personal services and operating expenses
17 shall be awarded to an entity that has personnel or experience, or both, in
18 implementing the EAST Initiative.

19 The provisions of this section shall be in effect only from July 1, 2003
20 through June 30, 2005.

21
22 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
24 PRIORITIZATION OF FUNDING. The State Board of Education shall give first
25 priority to allocating funding for those line-items contained in Section 1 of
26 this Act that further the State's goal of maintaining equitable funding of
27 students in the public schools of this State. Those line-items that further
28 this goal shall be those line-items that contribute to the State meeting the
29 Federal Range Ratio as it is described in 34 C.F.R. §§ 222.61, et seq.
30 (1994).

31
32 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXPLOR-
34 NET FUNDING PROVISION. Of the total appropriation authorized by this Act for
35 Technology Grants the Department of Education shall make available one
36 hundred eighty seven thousand five hundred seventy five dollars (\$187,575)

1 each fiscal year for Explor-Net Program initiatives to teach students
2 computer repair in a hands-on environment. The Department of Education shall
3 allocate General Revenue funding totaling no less than one hundred eighty
4 seven thousand five hundred seventy five dollars (\$187,575) each fiscal year
5 from the Department of Education Public School Fund Account to support the
6 Explor-Net Program. The Department shall either expend or have committed for
7 expenditure the monies allocated for the Explor-Net Program in order to
8 fulfill the provisions of this section.

9
10 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
12 LEADERSHIP ACADEMY - REDUCTION OF FUNDS RESTRICTION. Upon determination by
13 the Department of Education that a reduction in the amount of available
14 appropriation within the Department of Education Fund Account is required
15 from the amount appropriated, the reduction in the available appropriation
16 from the full amount appropriated for the Arkansas Leadership Academy shall
17 be limited to the average percentage reduction in the other appropriations to
18 the Department of Education from the Department of Education Fund Account.

19
20 SECTION 24. Subsection (c) of Section 3 of uncodified Act 1288 of 1993,
21 as amended, concerning the Pygmalion Commission is repealed:

22
23 ~~(c) The commission shall expire on June 30, 2003, unless the commission~~
24 ~~is continued by further act of the Arkansas General Assembly.~~

25
26 SECTION 25. Arkansas Code Annotated 6-17-2104(j) of The Educator
27 Compensation Act of 2001 is amended to read as follows:

28
29 (j) The required salary increase for targeted educators ~~who are~~
30 ~~prekindergarten teachers~~ shall only be required to be implemented if the
31 local school district has received sufficient state funds as determined by
32 the Department of Education available to completely implement the required
33 salary increase or proportion thereof for the given fiscal year.

34
35 SECTION 26. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
36 by this act shall be limited to the appropriation for such agency and funds

1 made available by law for the support of such appropriations; and the
2 restrictions of the State Purchasing Law, the General Accounting and
3 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
4 Procedures and Restrictions Act, or their successors, and other fiscal
5 control laws of this State, where applicable, and regulations promulgated by
6 the Department of Finance and Administration, as authorized by law, shall be
7 strictly complied with in disbursement of said funds.

8
9 *SECTION 27. LEGISLATIVE INTENT.* It is the intent of the General Assembly
10 that any funds disbursed under the authority of the appropriations contained
11 in this act shall be in compliance with the stated reasons for which this act
12 was adopted, as evidenced by the Agency Requests, Executive Recommendations
13 and Legislative Recommendations contained in the budget manuals prepared by
14 the Department of Finance and Administration, letters, or summarized oral
15 testimony in the official minutes of the Arkansas Legislative Council or
16 Joint Budget Committee which relate to its passage and adoption.

17
18 *SECTION 28. EMERGENCY CLAUSE.* *It is found and determined by the General*
19 *Assembly, that the Constitution of the State of Arkansas prohibits the*
20 *appropriation of funds for more than a two (2) year period; that the*
21 *effectiveness of this Act on July 1, 2003 is essential to the operation of*
22 *the agency for which the appropriations in this Act are provided, and that*
23 *the General Assembly recognizes the important contribution to education made*
24 *by the Pygmalion Commission on Nontraditional Education, and that recognizing*
25 *and identifying how the educational system is failing a child early enough to*
26 *provide meaningful intervention is necessary to improve the educational*
27 *outcomes for at-risk students, and the Pygmalion Commission shall expire on*
28 *June 30, 2003 unless the General Assembly continues the Commission by further*
29 *act, and that Section 24 of this Act shall become effective immediately upon*
30 *its passage and approval, and that the General Assembly further recognizes*
31 *the financial hardships placed on school district resources if the required*
32 *salary increase authorized by The Educator Compensation Act of 2001 is to*
33 *continue, and that Section 25 of this Act shall become effective immediately*
34 *upon its passage and approval due to the economic downturn of state revenues*
35 *and insufficient resources to provide school districts with sufficient funds*
36 *to implement the required salary increase, and that in the event of an*

1 extension of the Regular Session, the delay in the effective date of the
2 remaining sections of this Act beyond July 1, 2003, could work irreparable
3 harm upon the proper administration and provision of essential governmental
4 programs. Therefore, an emergency is declared to exist and this act being
5 immediately necessary for the preservation of the public peace, health, and
6 safety:

7 (1) Section 24 and Section 25 of this act shall become effective on:

8 (A) The date of its approval by the Governor;

9 (B) If the bill is neither approved nor vetoed by the Governor, the
10 expiration of the period of time during which the Governor may veto the bill;

11 or

12 (C) If the bill is vetoed by the Governor and the veto is
13 overridden, the date the last house overrides the veto; and

14 (2) All other sections of this act shall become effective on July 1,
15 2003.
