22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES - STATE OPERATIONS. There is hereby
25 established for the Department of Veterans' Affairs for the 2003-2005
26 biennium, the following maximum number of regular employees whose salaries
27 shall be governed by the provisions of the Uniform Classification and
28 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and
29 all laws amendatory thereto. Provided, however, that any position to which a
30 specific maximum annual salary is set out herein in dollars, shall be exempt
31 from the provisions of said Uniform Classification and Compensation Act. All
32 persons occupying positions authorized herein are hereby governed by the
33 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
34 Code §21-5-101), or its successor.

 9 funds as defined by Arkansas Code 19-4-801 of the Department of Veterans'
 10 Affairs, for refunds of unused fees paid by residents of the Veterans' Home
 11 of the Department of Veterans' Affairs for the biennial period ending June
 12 30, 2005, the following:

20 SECTION 9. APPROPRIATION - VETERANS' HOME - FAYETTEVILLE - STATE. There
 21 is hereby appropriated, to the Department of Veterans' Affairs, to be payable
 22 from the State General Services Fund Account, for the development of a
 23 Veterans' Home in Fayetteville, Arkansas for the biennial period ending June
 24 30, 2005, the sum of \$2,400,000.

25

26 SECTION 10. APPROPRIATION - VETERANS' HOME - FAYETTEVILLE - FEDERAL.
 27 There is hereby appropriated, to the Department of Veterans' Affairs, to be
 28 payable from Federal Funds as designated by the Chief Fiscal Officer of the
 29 State, for the development of a Veterans' Home in Fayetteville, Arkansas for
 30 the biennial period ending June 30, 2005, the sum of \$4,500,000.

31

32 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRAINING
 34 CONFERENCES. The funds appropriated herein for Aid to County Veterans Service
 35 Offices may also be used by the Department of Veteran Affairs to pay expenses
 36 of County Veterans Service Officers for attending regional or statewide

1 training conferences approved by the Department of Veterans Affairs and
2 designed to provide better trained and qualified Veterans Service Officers in
3 the various counties. Any such expenses paid by the Department of Veterans
4 Affairs from funds appropriated herein shall be on the same reimbursement
5 basis as the reimbursement of state employees for expenses incurred in
6 attending their official business. Provided, no County Veterans Service
7 Officer shall be entitled to receive reimbursement for expenses incurred in
8 attending more than two (2) approved conferences per year, per county. The
9 provisions of this section shall be in effect only from ~~July 1, 2001~~ July 1,
10 2003 through ~~June 30, 2003~~ June 30, 2005.

11
12 SECTION 12. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
13 by this act shall be limited to the appropriation for such agency and funds
14 made available by law for the support of such appropriations; and the
15 restrictions of the State Purchasing Law, the General Accounting and
16 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
17 Procedures and Restrictions Act, or their successors, and other fiscal
18 control laws of this State, where applicable, and regulations promulgated by
19 the Department of Finance and Administration, as authorized by law, shall be
20 strictly complied with in disbursement of said funds.

21
22 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General Assembly
23 that any funds disbursed under the authority of the appropriations contained
24 in this act shall be in compliance with the stated reasons for which this act
25 was adopted, as evidenced by the Agency Requests, Executive Recommendations
26 and Legislative Recommendations contained in the budget manuals prepared by
27 the Department of Finance and Administration, letters, or summarized oral
28 testimony in the official minutes of the Arkansas Legislative Council or
29 Joint Budget Committee which relate to its passage and adoption.

30
31 SECTION 14. EMERGENCY CLAUSE. It is found and determined by the General
32 Assembly, that the Constitution of the State of Arkansas prohibits the
33 appropriation of funds for more than a two (2) year period; that the
34 effectiveness of this Act on July 1, 2003 is essential to the operation of
35 the agency for which the appropriations in this Act are provided, and that in
36 the event of an extension of the Regular Session, the delay in the effective

1 date of this Act beyond July 1, 2003 could work irreparable harm upon the
2 proper administration and provision of essential governmental programs.
3 Therefore, an emergency is hereby declared to exist and this Act being
4 necessary for the immediate preservation of the public peace, health and
5 safety shall be in full force and effect from and after July 1, 2003.
