22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES - STATE OPERATIONS. There is hereby
25 established for the Department of Veterans' Affairs for the 2003-2005
26 biennium, the following maximum number of regular employees whose salaries
27 shall be governed by the provisions of the Uniform Classification and
28 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and
29 all laws amendatory thereto. Provided, however, that any position to which a
30 specific maximum annual salary is set out herein in dollars, shall be exempt
31 from the provisions of said Uniform Classification and Compensation Act. All
32 persons occupying positions authorized herein are hereby governed by the
33 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
34 Code §21-5-101), or its successor.

 9 authorized, for the Department of Veterans' Affairs - Veterans' Home for the
 10 2003-2005 biennium, the following maximum number of part-time or temporary
 11 employees, to be known as "Extra Help", payable from funds appropriated
 12 herein for such purposes: seven (7) temporary or part-time employees, when
 13 needed, at rates of pay not to exceed those provided in the Uniform
 14 Classification and Compensation Act, or its successor, or this act for the
 15 appropriate classification.

17 SECTION 5. APPROPRIATION - VETERANS' HOME DIVISION. There is hereby
 18 appropriated, to the Department of Veterans' Affairs, to be payable from the
 19 State General Services Fund Account, for personal services and operating
 20 expenses of the Department of Veterans' Affairs - Veterans' Home for the

7 SECTION 8. APPROPRIATIONS - VETERANS' HOME CASH. There is hereby
 8 appropriated, to the Department of Veterans' Affairs, to be payable from cash
 9 funds as defined by Arkansas Code 19-4-801 of the Department of Veterans'
 10 Affairs, for refunds of unused fees paid by residents of the Veterans' Home
 11 of the Department of Veterans' Affairs for the biennial period ending June
 12 30, 2005, the following:

20 SECTION 9. APPROPRIATION - VETERANS' HOME - FAYETTEVILLE - STATE. There
 21 is hereby appropriated, to the Department of Veterans' Affairs, to be payable
 22 from the Department of Human Services Grants Fund Account, for the
 23 development of a Veterans' Home in Fayetteville, Arkansas for the biennial
 24 period ending June 30, 2005, the sum of \$2,400,000.

25

26 SECTION 10. APPROPRIATION - VETERANS' HOME - FAYETTEVILLE - FEDERAL.
 27 There is hereby appropriated, to the Department of Veterans' Affairs, to be
 28 payable from Federal Funds as designated by the Chief Fiscal Officer of the
 29 State, for the development of a Veterans' Home in Fayetteville, Arkansas for
 30 the biennial period ending June 30, 2005, the sum of \$4,500,000.

31

32 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING
 34 RESTRICTIONS. The appropriation and funding authorized in Section 9 of this
 35 Act shall only be utilized in the event that funding is not provided from the
 36 General Improvement Fund or its successor fund or fund accounts for the
development of a Veteran's Home in Fayetteville, Arkansas.

1 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRAINING
3 CONFERENCES. The funds appropriated herein for Aid to County Veterans Service
4 Offices may also be used by the Department of Veteran Affairs to pay expenses
5 of County Veterans Service Officers for attending regional or statewide
6 training conferences approved by the Department of Veterans Affairs and
7 designed to provide better trained and qualified Veterans Service Officers in
8 the various counties. Any such expenses paid by the Department of Veterans
9 Affairs from funds appropriated herein shall be on the same reimbursement
10 basis as the reimbursement of state employees for expenses incurred in
11 attending their official business. Provided, no County Veterans Service
12 Officer shall be entitled to receive reimbursement for expenses incurred in
13 attending more than two (2) approved conferences per year, per county. The
14 provisions of this section shall be in effect only from ~~July 1, 2001~~ July 1,
15 2003 through ~~June 30, 2003~~ June 30, 2005.

16

17 SECTION 13. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
18 by this act shall be limited to the appropriation for such agency and funds
19 made available by law for the support of such appropriations; and the
20 restrictions of the State Purchasing Law, the General Accounting and
21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
22 Procedures and Restrictions Act, or their successors, and other fiscal
23 control laws of this State, where applicable, and regulations promulgated by
24 the Department of Finance and Administration, as authorized by law, shall be
25 strictly complied with in disbursement of said funds.

26

27 SECTION 14. LEGISLATIVE INTENT. It is the intent of the General Assembly
28 that any funds disbursed under the authority of the appropriations contained
29 in this act shall be in compliance with the stated reasons for which this act
30 was adopted, as evidenced by the Agency Requests, Executive Recommendations
31 and Legislative Recommendations contained in the budget manuals prepared by
32 the Department of Finance and Administration, letters, or summarized oral
33 testimony in the official minutes of the Arkansas Legislative Council or
34 Joint Budget Committee which relate to its passage and adoption.

35

36 SECTION 15. EMERGENCY CLAUSE. It is found and determined by the General

1 Assembly, that the Constitution of the State of Arkansas prohibits the
2 appropriation of funds for more than a two (2) year period; that the
3 effectiveness of this Act on July 1, 2003 is essential to the operation of
4 the agency for which the appropriations in this Act are provided, and that in
5 the event of an extension of the Regular Session, the delay in the effective
6 date of this Act beyond July 1, 2003 could work irreparable harm upon the
7 proper administration and provision of essential governmental programs.
8 Therefore, an emergency is hereby declared to exist and this Act being
9 necessary for the immediate preservation of the public peace, health and
10 safety shall be in full force and effect from and after July 1, 2003.
