9 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL  
10 SERVICES AND OPERATING EXPENSES FOR THE JUDICIAL  
11 DISCIPLINE AND DISABILITY COMMISSION FOR THE  
12 BIENNIAL PERIOD ENDING JUNE 30, 2005; AND FOR  
13 OTHER PURPOSES.

16 AN ACT FOR THE JUDICIAL DISCIPLINE AND  
17 DISABILITY COMMISSION APPROPRIATION FOR  
18 THE 2003-2005 BIENNIUM.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for  
25 the Judicial Discipline and Disability Commission for the 2003-2005 biennium,  
26 the following maximum number of regular employees whose salaries shall be  
27 governed by the provisions of the Uniform Classification and Compensation Act  
28 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory  
29 thereto. Provided, however, that any position to which a specific maximum  
30 annual salary is set out herein in dollars, shall be exempt from the  
31 provisions of said Uniform Classification and Compensation Act. All persons  
32 occupying positions authorized herein are hereby governed by the provisions  
33 of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-  
34 101), or its successor.

12 SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated, to  
 13 the Judicial Discipline and Disability Commission, to be payable from the  
 14 State Central Services Fund, for personal services and operating expenses of  
 15 the Judicial Discipline and Disability Commission for the biennial period  
 16 ending June 30, 2005, the following:

31 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
 33 CONTRACTUAL SERVICES LIMITED. No more than ~~\$75,000~~ \$78,750 of the funds  
 34 appropriated for Professional Fees and Services may be expended in the ~~2001-~~  
 35 ~~2002~~ 2003-2004 fiscal year, and no more than ~~\$75,000~~ \$82,500 of the funds may  
 36 be expended in the ~~2002-2003~~ 2004-2005 fiscal year for contractual services

1 of an attorney to represent the Commission when reviewing cases of judicial  
 2 misconduct. Provided further, none of these funds shall be spent for  
 3 contractual services of an attorney until it has been determined by the  
 4 Attorney General these services cannot be provided by his office.

5 The provisions of this section shall be in effect only from ~~July 1, 2001~~  
 6 July 1, 2003 through ~~June 30, 2003~~ June 30, 2005.

7  
 8 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
 9 by this act shall be limited to the appropriation for such agency and funds  
 10 made available by law for the support of such appropriations; and the  
 11 restrictions of the State Purchasing Law, the General Accounting and  
 12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 13 Procedures and Restrictions Act, or their successors, and other fiscal  
 14 control laws of this State, where applicable, and regulations promulgated by  
 15 the Department of Finance and Administration, as authorized by law, shall be  
 16 strictly complied with in disbursement of said funds.

17  
 18 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly  
 19 that any funds disbursed under the authority of the appropriations contained  
 20 in this act shall be in compliance with the stated reasons for which this act  
 21 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
 22 and Legislative Recommendations contained in the budget manuals prepared by  
 23 the Department of Finance and Administration, letters, or summarized oral  
 24 testimony in the official minutes of the Arkansas Legislative Council or  
 25 Joint Budget Committee which relate to its passage and adoption.

26  
 27 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General  
 28 Assembly, that the Constitution of the State of Arkansas prohibits the  
 29 appropriation of funds for more than a two (2) year period; that the  
 30 effectiveness of this Act on July 1, 2003 is essential to the operation of  
 31 the agency for which the appropriations in this Act are provided, and that in  
 32 the event of an extension of the Regular Session, the delay in the effective  
 33 date of this Act beyond July 1, 2003 could work irreparable harm upon the  
 34 proper administration and provision of essential governmental programs.  
 35 Therefore, an emergency is hereby declared to exist and this Act being  
 36 necessary for the immediate preservation of the public peace, health and

safety shall be in full force and effect from and after July 1, 2003.
