Disbursement of funds authorized 12 by this act shall be limited to the appropriation for such agency and funds 13 14 made available by law for the support of such appropriations; and the 15 restrictions of the State Purchasing Law, the General Accounting and 16 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 17 Procedures and Restrictions Act, or their successors, and other fiscal 18 control laws of this State, where applicable, and regulations promulgated by 19 the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds. 20

SECTION 28. LEGISLATIVE INTENT. It is the intent of the General Assembly 22 23 that any funds disbursed under the authority of the appropriations contained 24 in this act shall be in compliance with the stated reasons for which this act 25 was adopted, as evidenced by the Agency Requests, Executive Recommendations 26 and Legislative Recommendations contained in the budget manuals prepared by 27 the Department of Finance and Administration, letters, or summarized oral 28 testimony in the official minutes of the Arkansas Legislative Council or 29 Joint Budget Committee which relate to its passage and adoption.

31 <u>SECTION 29. EMERGENCY CLAUSE.</u> It is found and determined by the General 32 Assembly, that funds provided by the General Assembly for the operations of 33 the Arkansas State Claims Commission are, due to unforeseen circumstances, 34 insufficient for the Arkansas State Claims Commission to continue to provide 35 essential governmental services; that the provisions of this act will provide

36 the necessary monies for the Arkansas State Claims Commission to continue

1	such services; and that a delay in the effective date of this Act could work
2	irreparable harm upon the proper administration and provision of essential
3	governmental programs. Therefore, an emergency is hereby declared to exist
4	and this Act being necessary for the immediate preservation of the public
5	peace, health and safety shall be in full force and effect from and after the
6	date of its passage and approval. If the bill is neither approved nor vetoed
7	by the Governor, it shall become effective on the expiration of the period of
8	time during which the Governor may veto the bill. If the bill is vetoed by
9	the Governor and the veto is overridden, it shall become effective on the
10	date the last house overrides the veto.
