The maximum annual salary for the position assigned to grades shall be determined 27 in accordance with, but shall not exceed the maximum annual amount for the 28 29 grade assigned herein, as established in Arkansas Code 21-5-209. Except for the purpose of determining the maximum annual salary rate, which is to be 30 applicable to each of the positions to which a salary grade is assigned 31 32 hereinafter, in accordance with the provisions of Arkansas Code 21-5-209, all 33 positions set forth herein shall be exempt from other provisions of the Uniform Classification and Compensation Act, or its successor, but shall not 34 35 be exempt from the provisions of the Regular Salaries Procedures and 36 Restrictions Act, or its successor.

1	SECTION 11. EMERGENCY CLAUSE. It is found and determined by the General
2	Assembly, that the Constitution of the State of Arkansas prohibits the
3	appropriation of funds for more than a two (2) year period; that the
4	effectiveness of this Act on July 1, 2003 is essential to the operation of
5	the agency for which the appropriations in this Act are provided, and that in
6	the event of an extension of the Regular Session, the delay in the effective
7	date of this Act beyond July 1, 2003 could work irreparable harm upon the
8	proper administration and provision of essential governmental programs.
9	Therefore, an emergency is hereby declared to exist and this Act being
10	necessary for the immediate preservation of the public peace, health and
11	safety shall be in full force and effect from and after July 1, 2003.
