22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23

24 SECTION 1. REGULAR SALARIES - GENERAL OPERATIONS. There is hereby
25 established for the Department of Higher Education - General Operations for
26 the 2003-2005 biennium, the following maximum number of regular employees
27 whose salaries shall be governed by the provisions of the Uniform
28 Classification and Compensation Act (Arkansas Code §§21-5-201 et seq.), or
29 its successor, and all laws amendatory thereto. Provided, however, that any
30 position to which a specific maximum annual salary is set out herein in
31 dollars, shall be exempt from the provisions of said Uniform Classification
32 and Compensation Act. All persons occupying positions authorized herein are
33 hereby governed by the provisions of the Regular Salaries Procedures and
34 Restrictions Act (Arkansas Code §21-5-101), or its successor.

SECTION 15. SPECIAL LANGUAGE. Arkansas Code §19-5-302, concerning State General Government Funds is amended by adding a new subsection as follows:

(14)(A) Higher Education Salary Distribution Fund Account. The Higher Education Salary Distribution Fund Account shall be used for the distribution of salary and cost of living adjustments to the various institutions of higher education.

(B) The fund account shall consist of those general revenues and any

1 other funds as may be provided by law.

2
3 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
5 PROVISION. Upon certification by the Director of the Department of Higher
6 Education that transfers are needed to make maximum utilization of funds and
7 appropriations provided for financial aid programs, and with the approval of
8 the Chief Fiscal Officer of the State and a review by the Arkansas
9 Legislative Council, funds and appropriations may be transferred between
10 financial aid programs, except that funds and appropriations may not be
11 transferred for such purposes from either the Governor's Scholars Program or
12 the Academic Challenge Scholarships Program in excess of \$1,000,000 in the
13 aggregate in either fiscal year. Any transfer restrictions contained in
14 appropriation acts for the Department of Higher Education relating to
15 appropriation transfers from Governor's Scholars Program and Academic
16 Challenge Scholarships shall not be applicable to transfers between
17 Governor's Scholars and Academic Challenge Scholarship appropriations.

18 The provisions of this section shall be in effect only from ~~July 1, 2001~~

21 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LOANS. In
23 order to provide timely payments under financial aid appropriations made in
24 this Act, the Chief Fiscal Officer of the State is authorized to provide
25 loans from the Budget Stabilization Trust Fund to make available all funds
26 attributable to the financial aid programs under the then current official
27 revenue estimates. In the event of an unanticipated state revenue shortfall,
28 any such loans remaining at the end of a fiscal year shall be repaid from
29 revenues distributed in the first two months of the next fiscal year. Funds
30 for appropriations made in this Act for purposes other than financial aid
31 shall not be affected by the application of this provision.

35 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 FORCE 2000 DEVELOPMENT FUND PROCEDURES. After the amounts to be made
2 available to the various technical colleges have been determined as set out
3 in Arkansas Code 26-51-205(d)(2), such documents as may be necessary shall be
4 processed so that funds may be transferred from the Work Force 2000
5 Development Fund to the State Treasury fund or fund account from which the
6 technical college draws its general revenue support. Such funds as may be
7 transferred shall not exceed ~~74.45%~~ 77.19% of the total funds available from
8 the Work Force 2000 Development Fund during each fiscal year of the biennial
9 period ending ~~June 30, 2003~~ June 30, 2005.

10 In the event that a technical institute or comprehensive lifelong learning
11 center which receives support from the Work Force 2000 Development Fund as
12 determined by law transfers or merges into the Arkansas Technical College and
13 Community College System for which Work Force 2000 Development Fund monies
14 are determined by law, then the actual amount of support from the Work Force
15 2000 Development Fund in the preceding fiscal year for such educational
16 institution shall be made available irrespective of any other provision of
17 law which sets out maximum levels of support from such fund.

21 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

23 MAINTENANCE FUND. After the sum of \$13,200,000 has been deposited into the
24 Higher Education Building Maintenance Fund, the next \$10,000,000 or so much
25 as is collected, is to be transferred to the Research Development Fund there
26 to be used as provided by law.

32 EXPENDITURES. Proceeds derived from the repayment of loans as authorized in

34 Secondary Education Loans, the JR/SR Minority Teacher Scholars, ~~the~~
35 ~~Freshman/Sophomore Minority Grants~~, and the Minority Masters Fellows shall be
36 deposited into the State Treasury as "Refunds to Expenditures."

4 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

6 FORWARD. The balance of the funds and appropriations as provided in Section

1 AUDIT/REVIEW OF STATE SCHOLARSHIP FUNDS. Any post-secondary institution that
2 receives state scholarship funds administered by the Arkansas Department of
3 Higher Education shall be subject to audit/review of such funds by the
4 Division of Legislative Audit, upon approval of the Legislative Joint Audit
5 Committee.

16 APPROPRIATION TRANSFER PROCEDURES - AR GEOGRAPHICAL CRITICAL NEEDS MINORITY
17 TEACHER SCHOLARSHIP PROGRAM. The Director of the Arkansas Department of
18 Higher Education shall determine the amount available, up to \$200,000 per
19 fiscal year, to fund the Arkansas Geographical Critical Needs Minority
20 Teacher Scholarships and shall certify to the Chief Fiscal Officer of the
21 State and the State Treasurer such amount as is required to be transferred
22 from the Higher Education Grants Fund Account. Upon receiving such
23 certification, the Chief Fiscal Officer of the State and the State Treasurer

1 SECTION 37. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING
3 FOR SALARY INCREASES. New funding through the Revenue Stabilization Act
4 determined by the Arkansas Department of Higher Education to have been for
5 salary increases for each year of the 2003-2005 Biennium for Institutions of
6 Higher Education shall be used exclusively for salary increases. New funding
7 actually received for salary increases shall be spent exclusively for salary
8 increases based upon the state general revenue portion of total unrestricted
9 educational and general revenue. Funding received under this provision shall
10 be used for no purpose other than to provide such salary increases. Any
11 designated funds not used for salary increases shall be recouped at the end
12 of each fiscal year and transferred to the General Revenue Allotment Reserve
13 Fund.

17 SECTION 38. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
18 by this act shall be limited to the appropriation for such agency and funds

20 restrictions of the State Purchasing Law, the General Accounting and
21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
22 Procedures and Restrictions Act, or their successors, and other fiscal
23 control laws of this State, where applicable, and regulations promulgated by
24 the Department of Finance and Administration, as authorized by law, shall be
25 strictly complied with in disbursement of said funds.

26
27 SECTION 39. LEGISLATIVE INTENT. It is the intent of the General Assembly
28 that any funds disbursed under the authority of the appropriations contained
29 in this act shall be in compliance with the stated reasons for which this act
30 was adopted, as evidenced by the Agency Requests, Executive Recommendations
31 and Legislative Recommendations contained in the budget manuals prepared by
32 the Department of Finance and Administration, letters, or summarized oral
33 testimony in the official minutes of the Arkansas Legislative Council or
34 Joint Budget Committee which relate to its passage and adoption.

35
36 SECTION 40. EMERGENCY CLAUSE. It is found and determined by the General

1 Assembly, that the Constitution of the State of Arkansas prohibits the
2 appropriation of funds for more than a two (2) year period; that the
3 effectiveness of this Act on July 1, 2003 is essential to the operation of
4 the agency for which the appropriations in this Act are provided, and that in
5 the event of an extension of the Regular Session, the delay in the effective
6 date of this Act beyond July 1, 2003 could work irreparable harm upon the
7 proper administration and provision of essential governmental programs.
8 Therefore, an emergency is hereby declared to exist and this Act being
9 necessary for the immediate preservation of the public peace, health and
10 safety shall be in full force and effect from and after July 1, 2003.
