28	grade of Full time/B, to be elected by the qualified electors of the city of
29	Jacksonville.
30	(2) Little Rock shall have:
31	(A) Three (3) divisions of (1) district court with
32	jurisdiction only within the city limits of Little Rock, as now or in the
33	future may be constituted, and

	(B) One (1) full time judge for each division with a
35	(B) One (1) full time judge for each division with a salary status and grade of Full time/A, to be elected by the qualified

1	(3) North Little Rock shall have:
2	(A) Two (2) divisions of one (1) district court with

19	County district court shall be full time with a salary status and grade of
20	Full time/A.
21	(C) The judge of the Sherwood department of the Pulaski
22	County district court shall be part time with a salary status and grade of
23	Part time/2.
24	(D) The judge of the Wrightsville department of the
25	Pulaski County district court shall be part time with a salary status and
26	grade of Part time/6.

28	SECTION 26. (a) There is established for the District Courts of this
29	state a District Court Coordinator who shall be a private contractor and
30	receive professional fees in the amount of fifty thousand dollars (\$50,000)
31	for fiscal year 2003-2004 and fifty thousand dollars (\$50,000) for fiscal
32	year 2004-2005 to be payable from the State Administration of Justice Fund.
33	(b) The contract will be approved by the Chief Justice of the Arkansas
34	Supreme Court and the President of the District Judges Council.
35	
36	SECTION 27. (a) District courts shall be established under this

1	subchapter on the effective date of this act.
2	(b) The voters, at the 2004 nonpartisan judicial general election,
3	shall elect the number of district judges established under this subchapter,
4	to take office effective January 1, 2005.
