5	SECTION 2. Arkansas Code § 5-62-113 is amended to read as follows:		
6	5-62-113. Authority to make arrests.		
7	The agents of any society which is incorporated for the prevention of		
8	cruelty to animals, upon being appointed by the president of the society is		
9	any county of this state and upon being deputized by the sheriff of the		
10	county, may, within the county, make arrests and bring before any court or		
11	magistrate having jurisdiction, any offenders found violating the provisions		
12	of this act.		
13			
14	SECTION 3. Arkansas Code § 5-62-114 is amended to read as follows:		
15	5-62-114. Authority to take charge of animals and vehicles of arrested		
16	person.		
17	(a) When any person arrested is, at the time of arrest, in charge of		
18	any vehicle drawn by or containing any animal, any agent of a society for th		
19	prevention of cruelty to animals may take charge of the animal and the		
20	vehicle and its contents and deposit them in a safe place of custody, or		
21	deliver them into the possession of the police or sheriff of the county or		
22	place wherein the arrest was made, who shall thereupon assume the custody		
23	thereof.		
24	(b) However, without a search warrant under § 5-62-112 or without		
25	permission to enter from the landowner or lease holder, an agent of a society		
26	for the prevention of cruelty to animals shall have no authority to take		
27	charge or custody of an animal if the agent has entered upon or trespassed		
28	onto the land or real property of another person.

30	SECTION 4. Arkansas Code § 5-62-115 is repealed.		
31	5-62-115. Injunction against society.		
32	No injunction shall be granted against a society for the prevention of		
33	cruelty to animals or any of its officers or agents except upon motion after		
34	due notice and hearing thereof.
