Disbursement of funds authorized 18 19 by this act shall be limited to the appropriation for such agency and funds 20 made available by law for the support of such appropriations; and the 21 restrictions of the State Purchasing Law, the General Accounting and 22 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 23 Procedures and Restrictions Act, or their successors, and other fiscal 24 control laws of this State, where applicable, and regulations promulgated by 25 the Department of Finance and Administration, as authorized by law, shall be 26 strictly complied with in disbursement of said funds.

28 SECTION 22. LEGISLATIVE INTENT. It is the intent of the General Assembly 29 that any funds disbursed under the authority of the appropriations contained 30 in this act shall be in compliance with the stated reasons for which this act 31 was adopted, as evidenced by the Agency Requests, Executive Recommendations 32 and Legislative Recommendations contained in the budget manuals prepared by 33 the Department of Finance and Administration, letters, or summarized oral 34 testimony in the official minutes of the Arkansas Legislative Council or 35 Joint Budget Committee which relate to its passage and adoption. 36

1	SECTION 23. EMERGENCY CLAUSE. It is found and determined by the General
