17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
18

19 SECTION 1. Arkansas Code 19-5-205(e)(1)(B)(i) is amended to reflect  
20 current sources of special revenue income to the State Central Services Fund  
21 to read as follows:

22 (i) Those special revenues as specified in subdivisions (9), (11),  
23 (19), (21), (37), (75), (76), (77), (78), (79), (82), (83), (84), (85), (86),  
24 (87), (88), (89), (91), (96), (116), (118), (120), (124), (149), and (188),  
25 and ten percent (10%) of those special revenues as set out in subdivision  
26 (20) of § 19-6-301 of the Revenue Classification Law of Arkansas, § 19-6-101  
27 et seq.;

28  
29 SECTION 2. Arkansas Code 19-5-303(1)(1) is amended to reflect a name  
30 change for Westark College to read as follows:

4 sponsoring the monument or memorial and paying the cost of construction or  
5 placement.

6 (3) After construction, improvement, or placement is complete, the sponsor  
7 shall submit to the commission an affidavit stating the actual cost of  
8 construction, improvement, or placement, and if the commission determines  
9 that the actual cost is higher or lower than the estimate, the commission  
10 shall adjust the fee.

11 (4) The sponsor may donate or request a refund of any amount paid in excess
