Pursuant to the authority granted in § 19 of Amendment 51 11 to the Arkansas Constitution, § 7(i) of Amendment 51 to the Arkansas 12 Constitution, concerning registration record files, is amended to read as 13 follows: 14 (i)(1) Any election official The Secretary of State and any permanent 15 registrar in the state, including any local election official, may obtain 16 immediate electronic access to the information contained in the computerized 17 list. 18 (2) All voter registration information obtained by any local 19 election official in the state shall be electronically entered into the 20 computerized list on an expedited basis at the time the information is 21 provided to the local official. 22 (3) The Secretary of State shall provide the support as may be 23 required so that local election officials are able to enter the information. 24 25 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 26 Assembly of the State of Arkansas that the federal Help America Vote Act 27 establishes deadlines for the state's compliance with the act's voter 28 registration requirements; and that the immediate passage of this act is 29 necessary to ensure the state meets its deadlines. Therefore, an emergency 30 is declared to exist and this act being immediately necessary for the 31 preservation of the public peace, health, and safety shall become effective 32 on: 33 (1) The date of its approval by the Governor; 34 (2) If the bill is neither approved nor vetoed by the Governor, 35 the expiration of the period of time during which the Governor may veto the 36 bill; or
