## For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION FOR MISCELLANEOUS GRANTS AND EXPENSES AND VARIOUS AGENCY TRANSFERS FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION - DISBURSING OFFICER FOR THE BIENNIAL PERIOD ENDING JUNE 30, 2007; AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION - DISBURSING OFFICER - MISCELLANEOUS GRANTS AND EXPENSES AND VARIOUS AGENCY TRANSFERS APPROPRIATION FOR THE 2005-2007 BIENNIUM.
