For An Act To Be Entitled

10 AN ACT TO CREATE AN ADDITIONAL CIRCUIT JUDGESHIP
11 IN THE TWENTY-SECOND JUDICIAL DISTRICT; TO
12 PROVIDE FOR THE APPOINTMENT AND ELECTION OF THE
13 CIRCUIT JUDGE; AND FOR OTHER PURPOSES.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 16-13-3103, concerning judges of the
26 Twenty-second Judicial District, is amended to add an additional subsection
27 to read as follows:

28 (e)(1) Effective July 1, 2005, there is created in the Twenty-second
29 Judicial District an additional circuit judgeship, that shall have
30 jurisdiction in law, equity, probate, and juvenile matters.

31 (2) The Governor shall appoint a qualified person who is a
32 resident of the district to temporarily fill the Twenty-second Judicial
33 District circuit judgeship created by this subsection (e), and the appointed
34 person shall serve until December 31, 2006, or until a successor has been
35 elected and qualified.

36 (3)(A) The qualified electors of the district shall elect the



1 additional circuit judge created by this subsection (e) at the November 2006
2 general election to take office on January 1, 2007.

3 (B) The additional judge shall be elected from the
4 district, shall satisfy the same qualifications for holding office, and shall
5 receive the same salary, expenses, and other allowances as provided by law
6 for judges of the circuit courts.

7 (C) The judge shall serve for elected terms of six (6)
8 years.

9 (4) The county that comprises the Twenty-second Judicial
10 District shall provide courtroom and office facilities and supplies for the
11 judge of the circuit judgeship created by this subsection (e) which shall be
12 paid out of the county treasury in the same manner as other demands against
13 the county and out of funds appropriated by the quorum court of the county
14 for these purposes.

15 (5) There shall be provided for the judge of the circuit
16 judgeship created by this subsection (e) a court reporter and a trial court
17 administrative assistant whose salaries shall be fixed and paid in the manner
18 provided by law for court reporters and trial court administrative assistants
19 of the circuit courts of this state.

21 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
22 General Assembly of the State of Arkansas that the Judicial Resources
23 Assessment Committee has reviewed the caseloads of the various judicial
24 districts; that the caseload of the Twenty-second Judicial District
25 necessitates the appointment of an additional circuit judge; and that this
26 act is immediately necessary to ensure the smooth, efficient, and timely
27 administration of justice in the county affected. Therefore, an emergency is
28 declared to exist and this act being necessary for the preservation of the
29 public peace, health, and safety shall become effective on July 1, 2005.
