19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Arkansas Code § 27-50-1204(f), concerning penalties, is
22 amended to add an additional subdivision to read as follows:

23 (f)(1) A penalty assessed by the board shall be paid no later than
24 fifteen (15) days after the conclusion of the appeals process under the
25 Arkansas Administrative Procedure Act, § 25-15-201 et seq.

26 ~~(2)(A)(i) If not paid timely, a license or permit may be~~
27 ~~suspended until the penalty is paid.~~ If an entity or individual fails to pay
28 a fine or an installment payment as provided under subdivision (f)(1) of this
29 section, the Arkansas Towing and Recovery Board may provide written notice to
30 the Office of Motor Vehicle of the Revenue Division of the Department of
31 Finance and Administration of the failure to pay.

32 (ii) The notice of the failure to pay a fine ordered
33 by the Arkansas Towing and Recovery Board shall contain the following
34 information:

35 (a) The name of the entity or individual that
36 is subject to the fine;



1 (b) The vehicle identification number or other
2 identifying information for the vehicle owned by the entity or individual
3 that is the subject of the fine;

4 (c) The date the board imposed the fine;

5 (d) The amount of the fine;

6 (e) The date the fine or installment payment
7 became delinquent; and

8 (f) The amount of the fine or installment
9 payments that remain delinquent.

10 (B) Upon receipt of the notice of the failure to pay a
11 fine or installment payment, the Office of Motor Vehicle shall suspend the
12 tow vehicle license plate issued under § 27-14-601(a)(3)(J)(i) and
13 registration.

14 (C) A suspension under subdivision (f)(2) of this section
15 for failure to pay a fine ordered by the Arkansas Towing and Recovery Board
16 shall remain in effect until the Office of Motor Vehicle receives written
17 notice from the Arkansas Towing and Recovery Board that the fine has been
18 paid.
