22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code § 6-13-619(c) and (d), concerning meetings of
25 school district boards of directors, are amended to read as follows:

26 (c)(1)(A) A Except as provided under subsection (d) of this section, a
27 board member shall be physically present at a meeting to be counted for
28 purposes of a quorum or to vote.

29 (B) If a quorum is not established or maintained, a vote
30 shall not be taken until a quorum is established or restored.

31 (C) A majority of a quorum voting affirmatively is required
32 for the passage of any motion or resolution.

33 (D) Any member who abstains from voting shall be counted as
34 having voted against the motion or resolution.

35 (E)(i) If a member announces a conflict of interest with
36 regard to an issue, the member may leave the meeting until the voting on the



1 issue is concluded.

2 (ii) A member who leaves a meeting due to a conflict
3 of interest:

4 (a) Shall not be counted in the board's vote;
5 and

6 (b) Shall not be considered present for the
7 purpose of establishing a quorum until the member returns to the meeting
8 after the vote.

9 (2) Except as provided under subdivision (c)(1)(E)(ii) of this
10 section, for the purposes of this section, a quorum shall be a majority of
11 *the membership of the board of directors.*

12 (3) A quorum of the board of directors must be physically
13 present for the board to enter an executive session.

14 ~~(d)(1) Any member of the board of directors who misses three (3)~~
15 ~~regular and consecutive board of directors meetings during a school year for~~
16 ~~any reason other than military service of the member or illness of the member~~
17 ~~verified by a written sworn statement of the member's attending physician may~~
18 ~~be removed from office by a majority vote of the remaining board members, but~~
19 ~~only after an opportunity for a hearing before the board of directors upon~~
20 ~~fifteen (15) days' notice received by personal delivery or by certified mail~~
21 ~~with the return receipt signed by the addressee only requested~~ The board may
22 adopt a policy permitting a member of the board of directors who is unable to
23 be physically present at a meeting to attend the meeting remotely.

24 ~~(2) If the board of directors takes action to remove the member~~
25 ~~from office, the remaining members shall then appoint another individual to~~
26 ~~serve until the next annual school election, when electors shall select in~~
27 ~~the usual manner a director to serve the unexpired term of the removed member~~
28 For a member of the board of directors that attends a meeting remotely to be
29 counted for a quorum and to vote, the method used to permit the member of the
30 board of directors to attend remotely shall:

31 (A) Provide a method for the president of the board of
32 directors or the secretary of the board of directors to verify the identity
33 of the member of the board of directors attending remotely;

34 (B) Allow members of the board of directors that are
35 present and members of the public to hear the member of the board of
36 directors attending remotely at all times; and
