28 additional positions at institutions of higher education, is amended to read

33 additional positions at institutions of higher education, is amended to read

SECTION 3. Arkansas Code § 6-63-305(b)(26) and (27), concerning new or additional positions at institutions of higher education, are amended to read as follows:

- (26) Division of Agriculture of the University of Arkansas — ~~Agricultural Experiment Station~~ ~~250~~ 500
- ~~(27) University of Arkansas Cooperative Extension Service~~ ~~250~~

SECTION 4. Arkansas Code § 19-4-906(a)(059), concerning motor vehicle restrictions and authorizations for state entities and institutions of higher education, is amended to read as follows:
