9	(B) That provides the shooting equipment and fails to make		
10	reasonable and prudent efforts to determine the ability of a participant to		
11	engage safely in the shooting sports event or to determine the ability of \underline{a}		
12	participant to engage safely in the shooting sports event and to safely		
13	manage the particular shooting equipment based on the participant's		
14	representation of his or her ability;		
15	(C) That owns, leases, rents, or otherwise is in lawful		
16	possession and control of the facility at which a participant sustains an		
17	injury or dies because of a dangerous latent condition at the facility that
