17	(b)(1)(A) A host of a shooting sports event shall post and maintain		
18	signs that contain the warning notice specified in subdivision (b)(2) of this		
19	section.		
20	(B) The signs required under subdivision (b)(1)(A) of this		
21	section shall be placed in a clearly visible location at the facility or		
22	location where the host of a shooting sports event conducts the shooting		
23	sports event.		
24	(C) The warning notice specified in subdivision (b)(2) of		
25	this section shall appear on the sign in black letters with each letter to be		
26	a minimum of one inch (l") in height.		
27	(2) The signs described in subdivision (b)(1) of this section		
28	shall contain the following warning notice:		
29	<u>"WARNING</u>		
30	<u>Under Arkansas law, a host of a shooting sports event is not</u>		
31	liable for an injury to or the death of a participant in a shooting sports		
32	event resulting from the inherent risk of shooting sports events.".
