12 PROGRAM; TO AMEND THE LOAN REPAYMENT AMOUNTS UNDER
13 THE STATE TEACHER EDUCATION PROGRAM; AND FOR OTHER
14 PURPOSES.

18 TO AMEND THE STATE TEACHER EDUCATION
19 PROGRAM; AND TO AMEND THE ELIGIBILITY
20 REQUIREMENTS FOR LOAN FORGIVENESS AND

22 STATE TEACHER EDUCATION PROGRAM.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. Arkansas Code § 6-81-1604(b), concerning the standards for
27 loan repayments under the State Teacher Education Program, is amended to read
28 as follows:

29 (b) The division shall adopt standards for awarding the loan
30 repayments to ~~a public school teacher with an Arkansas teacher's license~~ an
31 applicant who is eligible to participate in the program under § 6-81-1605
32 ~~teaching in a:~~

- 33 (1) ~~Subject area with a teacher shortage; or~~
- 34 (2) ~~Geographic area with teacher shortage.~~

36 SECTION 2. Arkansas Code § 6-81-1605 is amended to read as follows:



1 6-81-1605. Eligibility.

2 To be eligible for the State Teacher Education Program, an applicant
3 shall:

4 (1) Teach full-time ~~at~~:

5 (A) At a public school district in a subject area or
6 geographic area with a teacher shortage, as identified by the Division of
7 Higher Education in consultation with the Division of Elementary and
8 Secondary Education; or

9 (B) In a public early childhood education program that
10 serves children whose ages may range from birth through prekindergarten;

11 (2) ~~Hold~~ Either:

12 (A) Hold a valid Arkansas teacher's license; or

13 (B) Hold a birth through prekindergarten teaching
14 credential from the Division of Child Care and Early Childhood Education of
15 the Department of Human Services; and

16 (3)(A) Meet additional continuing eligibility criteria
17 established by the Division of Higher Education.

18 (B) An individual who has earned a teaching license upon
19 the successful completion of an alternative educator preparation program is
20 an eligible student under this section.

21
22 SECTION 3. Arkansas Code § 6-81-1606(a), concerning loan repayments
23 under the State Teacher Education Program, is amended to read as follows:

24 (a)(1) The State Teacher Education Program shall be used to provide a
25 loan repayment for federal student loans in the amount of ~~six thousand~~
26 ~~dollars (\$6,000)~~ ten thousand dollars (\$10,000) per year for a maximum of
27 ~~three (3)~~ five (5) years for a ~~licensed teacher who graduated from a teacher~~
28 ~~education program after April 2004 and teaches in a public school in this~~
29 ~~state or successfully completed an alternative educator preparation program~~
30 ~~after April 2004 and teaches in a public school in the State Teacher~~
31 ~~Education Program;~~

32 ~~(A) In a subject area designated by the Division of Higher~~
33 ~~Education in consultation with the Division of Elementary and Secondary~~
34 ~~Education as having a critical shortage of teachers; and~~

35 ~~(B) Located in a geographical area of the state designated~~
36 ~~by the Division of Higher Education in consultation with the Division of~~

1 ~~Elementary and Secondary Education as having a critical shortage of teachers~~
2 ~~an individual who is eligible to participate in the program under § 6-81-~~
3 ~~1605.~~

4 (2) A licensed teacher who is given intensive support status
5 under the Teacher Excellence and Support System, § 6-17-2801 et seq., shall
6 be ineligible for receipt of funds under the ~~State Teacher Education Program~~
7 program for the school year.
