36	SECTION 2. Arkansas Code § 26-26-310, concerning certi	fication of the



1	amount of the property tax reduction and the distribution of property tax	
2	relief funds, is amended to add an additional subsection to read as follows:	
3	(e)(1) Except as provided in subdivision (e)(2) of this section, a	
4	distribution from the Property Tax Relief Trust Fund under this section shall	
5	be for the purpose of providing property tax relief.	
6	(2) The General Assembly shall not authorize a use of the funds	
7	in the Property Tax Relief Trust Fund for a purpose other than providing	
8	property tax relief under this section unless the purpose is approved by a	
9	three-fourths (3/4) vote of each house of the General Assembly.
