3	(ii) A health benefit plan provided under the
4	Workers' Compensation Law, § 11-9-101 et seq.;
5	(3)(A) "Healthcare insurer" means an insurance company, a
6	hospital and medical service corporation, a health maintenance organization,
7	a risk-based provider organization, or a sponsor of a self-funded health
8	benefit plan, that:
9	(i) Is subject to:
10	(a) The insurance laws of this state;
11	(b) Section 23-75-101 et seq., pertaining to
12	hospital and medical service corporations; or
13	(c) Section 23-76-101 et seq., pertaining to
14	health maintenance organizations; or
15	(ii) For a healthcare insurer in another state:
16	(a) Is not otherwise exempt from the insurance
17	laws of this state; and
18	(b) Has any subscribers in this state.
19	(B) "Healthcare insurer" includes the Arkansas Medicaid
20	Program.
21	(C) "Healthcare insurer" does not include an entity that
22	provides only eye and vision care benefits;
23	(4) "Healthcare provider" means:
24	(A) A doctor of medicine, a doctor of osteopathy, or
25	another licensed healthcare professional acting within the professional's
26	<u>licensed scope of practice; or</u>
27	(B) A healthcare facility licensed in the state where the
28	facility is located to provide healthcare services;
29	(5) "Healthcare service" means a healthcare procedure,
30	treatment, or service provided by a healthcare provider;
31	(6) "Mobile unit" means a premanufactured structure, trailer, or
32	self-propelled unit equipped with a chassis on wheels that:
33	(A) Is intended to provide healthcare services on a
34	temporary basis; and
35	(B) Conforms to applicable rules promulgated by the
36	Department of Health; and

1	(7) "Subscriber" means an individual who is entitled to receive
2	healthcare services under the terms of a health benefit plan.
3	(b) A healthcare insurer shall provide coverage to a subscriber for a
4	healthcare service that is:
5	(1) Provided in a mobile unit;
6	(2) Billed by a healthcare provider using the place-of-service
7	code designated for a mobile unit; and
8	(3) Otherwise covered by the healthcare insurer in another place
9	of service.
10	(c) A healthcare insurer shall ensure that a subscriber's cost-sharing
11	requirement for a healthcare service that is provided in a mobile unit is no
12	less favorable than the cost-sharing requirement that is applicable to the
13	same healthcare service provided in another place of service.
