26	(a) On and after January 1, 2026, a health benefit plan that is		
27	offered, issued, renewed, delivered, or extended in this state shall provide		
28	coverage for breastfeeding and lactation consultant services to an enrollee.		
29	(b) The coverage for breastfeeding and lactation consultant services		
30	under subsection (a) of this section:		
31	(1) Is not subject to an annual deductible, copayment, or		
32	coinsurance limit as established for other covered benefits under a health		
33	benefit plan; and		
34	(2) Does not diminish or limit benefits otherwise allowable		
35	under a health benefit plan.
