26	(7)(A) "H	ealthcare insurer" means an entity th	at is subject to							
27	state insurance regula	tion and provides <u>or administers</u> heal	th insurance in							
28	this state.									
29	(B)	"Healthcare insurer" includes:								
30		(i) An insurance company;								
31		(ii) A health maintenance organiza	tion;							
32		(iii) A hospital and medical servi	ce corporation;							
33		(iv) A risk-based provider organiz	ation;							
34		(v) A sponsor of a nonfederal self	-funded							
35	governmental plan; <del>and</del>

4	SECTION 2. Arkansas Code § 23-99-1203(a), concerning the prohibited							
5	activities under the Healthcare Contracting Simplification Act, is amended to							
6	read as follows:							
7	(a) Except as provided in subsections (b) and (d) of this section, a							
8	contracting entity shall not:							
9	(1) Offer to a healthcare provider a healthcare contract that							
10	includes an all-products clause;							
11	(2) Enter into a healthcare contract with a healthcare provider							
12	that includes an all-products clause; <del>or</del>							
13	(3) Amend or renew an existing healthcare contract previously							
14	entered into with a healthcare provider so that the healthcare contract as							
15	amended or renewed adds or continues to include an all-products clause; or							
16	(4) Require a healthcare provider to accept multiple health							
17	benefit plans that differ in reimbursement rates or other financial terms for							
18	the healthcare provider.

20	SECTION 3. Arkansas Code § 23-99-1210 is amended to read as follows:							
21	23-99-1210. Healthcare contract or provider network — Prohibition.							
22	(a) A healthcare insurer contracting entity shall not:							
23	(1) Lease, rent, or sell a healthcare contract or provider							
24	network of a health benefit plan to another <u>contracting entity</u> , healthcare							
25	insurer, or third-party administrator; or							
26	(2) In any manner allow the use of a healthcare contract or							
27	provider network of a health benefit plan by another contracting entity,							
28	healthcare insurer, or third-party administrator.							
29	(b)(1) A violation of this section is:							
30	(A) An unfair trade practice under § 23-66-206; and							
31	(B) Subject to the Trade Practices Act, § 23-66-201 et							
32	seq.							
33	(2) If a healthcare contract contains a provision that violates							
34	this section, then the provision under the healthcare contract is void.							
35	(c) This section does not apply if a <del>healthcare insurer</del> <u>contracting</u>							
36	entity:

1	(1) Grants Is a dental-only health benefit plan and grants								
2	access to the healthcare insurer's contracting entity's provider network								
3	contract to another <u>contracting entity,</u> healthcare insurer <u>,</u> or <del>entity</del> <u>third-</u>								
4	party administrator that is:								
5	(A) An affiliate of the healthcare insurer contracting								
6	<u>entity;</u> or								
7	(B) Operating according to the same brand licensee program								
8	as the <del>healthcare insurer</del> contracting entity; or								
9	(2) Provides notice of the intent to lease, rent, or sell a								
10	healthcare contract or provider network of a health benefit plan to another								
11	contracting entity, healthcare insurer, or third-party administrator;								
12	(3) Allows a healthcare provider that is a party to the								
13	healthcare contract or provider network of a health benefit plan the								
14	opportunity to opt out of participating in the:								
15	(A) Proposed lease, rental, or sale of a healthcare								
16	contract or provider network of a health benefit plan entirely upon the								
17	execution or renewal of the healthcare contract; and								
18	(B) Lease, rental, or sale of a healthcare contract with								
19	respect to an individual <u>contracting entity,</u> healthcare insurer, or third-								
20	party administrator upon notice that the individual contracting entity,								
21	healthcare insurer, or third-party administrator has violated the terms of								
22	the healthcare contract; <del>and</del> <u>or</u>								
23	(4) Provides contact information for the contracting entity,								
24	healthcare insurer, or third-party administrator using the healthcare								
25	contract or provider network of a health benefit plan, including without								
26	limitation:								
27	(A) Contact name;								
28	(B) Mailing address;								
29	(C) Direct telephone number for customer service matters;								
30	and								
31	(D) Direct email address for customer service matters.

33	SECTION 4. Arkansas Code Title 23, Chapter 99, Subchapter 12, is								
34	amended to add an additional section to read as follows:								
35	23-99-1211. Waiver prohibited.
