## For An Act To Be Entitled

9 AN ACT TO PROHIBIT A PERSON THAT IS EMPLOYED OR HAS A  
10 DIRECT OR INDIRECT FINANCIAL INTEREST IN A FIRM,  
11 BUSINESS, OR ORGANIZATION THAT OWNS, OPERATES,  
12 REPRESENTS, OR APPLIES FOR A SOLID WASTE LICENSE OR  
13 PERMIT FROM SERVING AS A MEMBER ON CERTAIN  
14 COMMISSIONS AND BOARDS; AND FOR OTHER PURPOSES.

## Subtitle

18 TO PROHIBIT A PERSON THAT IS EMPLOYED OR  
19 HAS A DIRECT OR INDIRECT INTEREST IN AN  
20 ORGANIZATION THAT OWNS, OPERATES,  
21 REPRESENTS, OR APPLIES FOR A SOLID WASTE  
22 LICENSE OR PERMIT FROM SERVING AS A  
23 MEMBER ON CERTAIN BOARDS.

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
26

27 SECTION 1. Arkansas Code § 8-4-104, concerning the membership of the  
28 Arkansas Pollution Control and Ecology Commission, is amended to add an  
29 additional subsection to read as follows:

30 (h) A person shall not serve as a member of the Arkansas Pollution  
31 Control and Ecology Commission if he or she is employed by a firm, business,  
32 or organization that owns, operates, represents, or applies for a solid waste  
33 license or permit or in which that person has a direct or indirect financial  
34 interest.

36 SECTION 2. Arkansas Code § 8-6-703, concerning the creation of



1 regional solid waste planning districts and boards, is amended to add an  
2 additional subsection to read as follows:

3 (d) A person shall not serve as a member of the board if he or she is  
4 employed by a firm, business, or organization that owns, operates,  
5 represents, or applies for a solid waste license or permit or in which that  
6 person has a direct or indirect financial interest.

8 SECTION 3. Arkansas Code § 8-6-904(e), concerning the solid waste  
9 licensing committee to advise and assist in the administration of the solid  
10 waste licensing program, is amended to read as follows:

11 ~~(e) No member of the committee~~ A person shall participate in any  
12 ~~licensing decision involving the firm or organization by which that member is~~  
13 ~~employed or~~ not serve as a member of the committee if he or she is employed  
14 by a firm, business, or organization that owns, operates, represents, or  
15 applies for a solid waste license or permit under this subchapter or in which  
16 ~~that member~~ person has a direct or indirect financial interest.
