26	(A) The person commits or attempts to commit:
27	(i) Terrorism, as defined in § 5-54-205;
28	(ii) Rape, § 5-14-103;
29	(iii) Kidnapping, § 5-11-102;
30	(iv) Vehicular piracy, § 5-11-105;
31	(v) Robbery, § 5-12-102;
32	(vi) Aggravated robbery, § 5-12-103;
33	(vii) Residential burglary, § 5-39-201(a);
34	<pre>(viii) Commercial burglary, § 5-39-201(b);</pre>
35	(ix) Aggravated residential burglary, § 5-39-204;
36	(x) A <del>felony</del> violation of the Uniform Controlled



1	Substances Act, §§ $5-64-101 - 5-64-508$ , involving an actual delivery of a
2	controlled substance; or
3	(xi) First degree escape, § 5-54-110; and
4	(B) In the course of and in furtherance of the <del>felony</del>
5	offense or in immediate flight from the felony offense, the person or an
6	accomplice causes the death of a person under circumstances manifesting
7	extreme indifference to the value of human life;
