23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25	SECTION 1. Arkansas Code Title 21, Chapter 8, Subchapter 6, is amend	led
26	to add an additional section to read as follows:	
27	21-8-608. Lobbying for covered foreign entity prohibited — Definiti	<u>.on</u>
28	— Penalties.	
29	(a) As used in this section:	
30	(1) "Covered foreign entity" means an individual, foreign	
31	government, or a party other than an individual or foreign government:	
32	(A) On the Consolidated Screening List or Entity List as	<u>}</u>
33	designated by the United States Secretary of Commerce;	
34	(B) Domiciled in the People's Republic of China or the	
35	Russian Federation;	
36	(C) Under the influence or control by the government of	

1	the People's Republic of China or the Russian Federation; or
2	(D) That is a subsidiary or affiliate of an individual,
3	government, or party referred to in subdivisions (a)(1)-(3) of this section;
4	<u>and</u>
5	(2) "Under the influence or control" means the People's Republic
6	of China, the Russian Federation, or an agent of the People's Republic of
7	China or the Russian Federation is:
8	(A) Exercising power or authority to regulate decisions
9	over the covered foreign entity; or
10	(B) Governing, managing, directing, or otherwise
11	overseeing decision making for the covered foreign entity.
12	(b) A person who receives a monetary benefit for lobbying shall not
13	lobby on behalf of a covered foreign entity.
14	(c) A person convicted of violating subsection (b) of this section
15	shall be guilty of:
16	(1) For the first offense, a violation with a fine of not less
17	than fifty dollars (\$50.00) and not more than three thousand five hundred
18	dollars (\$3,500);
19	(2) For the second offense, an unclassified misdemeanor with:
20	(A) A term of imprisonment not to exceed fix (6) months;
21	(B) A fine of five thousand dollars (\$5,000); or
22	(C) Both the term of imprisonment and fine under
23	subdivisions (c)(2)(A) and (B) of this section; and
24	(3) For the third or subsequent offense, an unclassified felony
25	with:
26	(A) A term of imprisonment not to exceed one (1) year;
27	(B) A fine of ten thousand dollars (\$10,000); or
28	(C) Both the term of imprisonment and fine under
29	subdivisions (c)(3)(A) and (B) of this section.
