9 AN ACT TO AMEND PROVISIONS OF THE ARKANSAS CODE  
10 CONCERNING THE ARKANSAS SCHOOL FOR THE BLIND AND THE  
11 ARKANSAS SCHOOL FOR THE DEAF; TO TRANSFER THE  
12 ARKANSAS SCHOOL FOR THE BLIND AND THE ARKANSAS SCHOOL  
13 FOR THE DEAF TO THE ARKANSAS SCHOOL FOR THE DEAF AND  
14 BLIND; TO DECLARE AN EMERGENCY; AND FOR OTHER  
15 PURPOSES.

## Subtitle

19 TO AMEND PROVISIONS OF THE ARKANSAS CODE  
20 CONCERNING THE ARKANSAS SCHOOL FOR THE  
21 BLIND AND THE ARKANSAS SCHOOL FOR THE  
22 DEAF; AND TO DECLARE AN EMERGENCY.  
23

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
25

26 SECTION 1. Arkansas Code Title 6, Chapter 43, Subchapter 1 is amended  
27 to read as follows:

28 6-43-101. Board of trustees.

29 (a) There is created ~~an honorary~~ a board constituting the Board of  
30 Trustees of the Arkansas School for the ~~Blind and the Arkansas School for the~~  
31 Deaf and Blind.

32 (b) ~~(1)~~ The board shall consist of five (5) members appointed by the  
33 Governor.

34 ~~(2) The Governor, by and with the advice and consent of the~~  
35 ~~Senate, shall appoint the members of the board.~~

36 ~~(3) The Secretary of State shall furnish a certificate to each~~



~~board member within ten (10) days following appointment, whereupon the appointee shall notify the Governor and the Secretary of State in writing of his or her acceptance of the appointment within thirty (30) days, and if the appointee fails to give notice of his or her acceptance within the time required, then the appointment shall be declared void and another appointment shall be made.~~

(c)(1) Members of the board appointed by the Governor under the provisions of this section, ~~in addition to possessing~~ shall:

(A) Possess the qualifications of an elector, ~~shall reside; and~~

(B) Reside in the State of Arkansas.

(2)(A) The Governor, Attorney General, Secretary of State, Auditor of State, Treasurer of State, Commissioner of State Lands, Supreme Court Justices, and the directing head of any state department, state agency, or state institution shall be ineligible for membership on the board provided for in this section during the time for which he or she was elected or appointed.

(B) No individual may be a member of ~~more than one (1) of the boards~~ the Board of Trustees of the Arkansas School for the Deaf and Blind created under the provisions of this section and another board created under § 25-17-201 at the same time.

~~(3) There shall be at all times one (1) member of the board who is a deaf person who fluently utilizes deaf sign language.~~

~~(d)(1)~~ The term of office for each member shall commence on January 15 and shall end on January 14 of the fifth year following the year in which the regular term commenced.

~~(2)(A) The Governor shall submit to the Senate for approval the names of all appointments made by him or her to fill expired terms within ten (10) days following the appointment.~~

~~(B) The members appointed by the Governor to fill vacancies caused by the expiration of the terms of members may qualify and hold office until the appointments are rejected by the Senate.~~

(e) Any vacancies arising in the membership of the board for any reason other than the expiration of the regular terms for which the members were appointed shall be filled by the appointment of the Governor, ~~subject to the approval by a majority of the remaining members of the board,~~ and shall

1 be thereafter effective until the expiration of the regular terms.

2 (f)(1) Before entering upon his or her respective duties, each board  
3 member shall take and subscribe and file in the office of the Secretary of  
4 State an oath to support the United States Constitution and the Arkansas  
5 Constitution and to faithfully perform the duties of the office upon which he  
6 or she is about to enter and that he or she will not be or become interested,  
7 directly or indirectly, in any contract made by the board.

8 (2)(A) Any violation of the oath shall be a Class B misdemeanor.

9 (B) Any contract entered into in violation of the oath  
10 shall be void.

11 (g) The board shall meet at least monthly and shall fix a regular date  
12 for the monthly meeting.

13 (h) Each member of the board may receive expense reimbursement in  
14 accordance with § 25-16-901 et seq.

15 (i)~~(1)~~ The Governor shall have the power to remove any member of the  
16 board before the expiration of his or her term for cause ~~only~~, after notice  
17 and hearing.

18 ~~(2) The removal shall become effective only when approved in~~  
19 ~~writing by a majority of the total number of the board, but the member~~  
20 ~~removed or his or her successor shall have no right to vote on the question~~  
21 ~~of removal.~~

22 ~~(3) The removal action shall be filed with the Secretary of~~  
23 ~~State, together with a complete record of the proceedings at the hearing.~~

24 ~~(4)(A) An appeal may be taken to the Pulaski County Circuit~~  
25 ~~Court by the Governor or the member ordered removed, and the appeal shall be~~  
26 ~~tried de novo on the record of the hearing before the Governor.~~

27 ~~(B) An appeal may be taken from the circuit court to the~~  
28 ~~Supreme Court, which shall likewise be tried de novo.~~

29  
30 6-43-102. Powers and duties of board.

31 (a) The Board of Trustees of the Arkansas School for the Deaf and  
32 ~~Blind and the Arkansas School for the Deaf~~ created in § 6-43-101 is charged  
33 with the management and control of the Arkansas School for the Deaf and Blind  
34 ~~and the Arkansas School for the Deaf.~~

35 (b) The board shall ~~have the power, authority, and duties formerly~~  
36 ~~conferred by law on the board it succeeds including those set forth below:~~

1           ~~(1) The board shall exercise such powers of supervision and~~  
 2 control as are not specifically reserved to ~~superintendents the~~  
 3 Superintendent of the Arkansas School for the Deaf and Blind; and.

4           ~~(2) The board, in consultation with the Secretary of the~~  
 5 ~~Department of Education, shall fix the salaries of officers and employees not~~  
 6 ~~already fixed by law.~~

7           (c) The board may adopt policies for the governance of the school as  
 8 deemed necessary and in consultation with the Secretary of the Department of  
 9 Education.

10          (d) The board shall:

11           (1) Keep a record of all board proceedings; and

12           (2) Adopt formal operating procedures.

13          (e) The superintendent, general business manager, and teachers of the  
 14 school shall not be eligible for the board while employed by the school.

15

17          (a) There is established the position of the Superintendent of the  
 18 Arkansas School for the Deaf and Blind.

19          (b) The immediate conduct and management of the Arkansas School for  
 20 the Deaf and Blind and the Arkansas School for the Deaf, school employees,  
 21 and students enrolled in the school shall be entrusted to ~~superintendents the~~  
 22 superintendent.

23          ~~(b)(c)(1)(A)~~ (c)(1)(A) The Board of Trustees of the Arkansas School for the Deaf  
 24 and Blind and the Arkansas School for the Deaf, in consultation with the  
 25 Secretary of the Department of Education, shall select ~~the superintendents of~~  
 26 the institutions committed to its care a superintendent from the candidates  
 27 recommended by the secretary.

28                   (B) The superintendent shall be selected based on his or  
 29 her previous training and qualifications relevant to the education of  
 30 students enrolled in the school.

31           (2)(A) The board may recommend to the secretary termination,  
 32 suspension, or other discipline permitted by law of the superintendent.

33                   (B) The secretary may terminate, suspend, or otherwise  
 34 discipline the superintendent in accordance with applicable policies and  
 35 laws.

36          ~~(c)(1) Each of the superintendents shall be required to give bond in a~~

~~sum fixed by the board, payable to the State of Arkansas, for the faithful discharge of his or her duties and the proper accounting for all moneys and property coming into his or her possession as such officer.~~

~~(2) The bonds shall be made by any surety company authorized to do business in Arkansas, approved by the Governor, filed in the office of the Secretary of State, and paid for by the state out of current expenses appropriated by the respective institutions.~~

~~(d) The superintendents of the schools shall be required to give their entire time to the management and operation of their respective institutions and shall be selected because of their previous training and fitness to care for the schools entrusted to their care.~~

(d) The board may, in consultation with the secretary, require the superintendent or other school officials to reside on the school campus.

(e) The superintendent shall:

(1) Have a superintendent license; and

(2) Be responsible for the management and operation of the school.

6-43-104. Employees generally.

~~(a) The superintendents shall have power to~~ superintendent may select and engage all employees of the schools at salaries fixed by the Board of Trustees of the Arkansas School for the Deaf and Blind and the Arkansas School for the Deaf in consultation with the Secretary of the Department of Education in accordance with state law, reporting the same for approval to the board Board of Trustees of the Arkansas School for the Deaf and Blind at the next regular meeting thereof of the board.

~~(b) The superintendents shall have the power to remove employees of the respective schools and may remove any employee at any time in their discretion for cause, but, in case of removal, the superintendent shall report the removal and the ground therefor to the board and the secretary~~ Each employee of the school, as a state employee, shall be subject to and receive the benefits of the provisions of Title 21 of the Arkansas Code, including without limitation policies and procedures established for the implementation of all provisions that are applicable to state employees.

(c) A teacher for a student with sensory impairments is eligible for a salary differential after he or she becomes certified by the Department of

1 Education in teaching students who are blind, visually impaired, deaf, or  
2 hard of hearing.

5 (a) ~~Every parent, guardian, or other person having control of any~~  
6 ~~minor over eight (8) years of age who is defective in hearing or sight to the~~  
7 ~~extent that he or she cannot be benefited by instruction in the public~~  
8 ~~schools shall be required to send such a minor to the The Arkansas School for~~  
9 ~~the Deaf and Blind or the Arkansas School for the Blind shall maintain~~  
10 ~~student records as required by law and rules applicable to public school~~  
11 ~~districts.~~

12 (b) ~~The minor shall continue to attend the schools for a term of at~~  
13 ~~least thirty-two (32) weeks each year until he or she has completed the~~  
14 ~~course of instruction prescribed for the schools by the Board of Trustees of~~  
15 ~~the Arkansas School for the Deaf and Blind and the Arkansas School for the~~  
16 ~~Deaf or any other body or person designated by law to have control of the~~  
17 ~~schools, respectively, or until he or she has been discharged by the~~  
18 ~~superintendent of the school may adopt a student attendance policy necessary~~  
19 ~~to ensure compliance with the purpose and function of the school.~~

23 ~~by the board or any other body or person designated by law to have control of~~  
24 ~~the schools for a time equal to that required by subsection (b) of this~~  
25 ~~section;~~

26 (2) ~~Physical incapacity for school work; or~~

27 (3) ~~Any other reason deemed good and sufficient by the~~  
28 ~~superintendent of the school with the approval of the board.~~

29 (d)(1) ~~Failure for a period of one (1) week within the school year to~~  
30 ~~send such a minor to school shall constitute an offense.~~

31 (2) ~~However, the time necessary for such a minor to travel from~~  
32 ~~his or her home to Little Rock shall not be counted as time absent from~~  
33 ~~school.~~

34 (e) ~~Any person who induces or attempts to induce such deaf or blind~~  
35 ~~minor to absent himself or herself from school or who employs or harbors such~~  
36 ~~a minor unlawfully while the schools are in session shall be guilty of a~~

1 ~~violation and upon conviction shall be fined not less than twenty dollars~~  
2 ~~(\$20.00) nor more than fifty dollars (\$50.00) for each offense.~~

3 ~~(f) It shall be the duty of county boards, or the boards' designees,~~  
4 ~~school attendance officers, prosecuting attorneys, and any special attendance~~  
5 ~~officers appointed by the Arkansas School for the Deaf and the Arkansas~~  
6 ~~School for the Blind as well as all peace officers to enforce the provisions~~  
7 ~~of this section.~~

8 ~~(g) Any parent, guardian, or other person in charge of such a minor or~~  
9 ~~minors who fails or refuses to comply with the requirements of this section~~  
10 ~~shall be guilty of a violation and upon conviction shall be fined not less~~  
11 ~~than ten dollars (\$10.00) nor more than fifty dollars (\$50.00) for each~~  
12 ~~offense.~~

13  
14 ~~6-43-106. Deaf and blind children — Out-of-state facilities.~~

15 ~~(a) The Arkansas School for the Blind is authorized to expend~~  
16 ~~available funds for the purpose of sending children under twenty-one (21)~~  
17 ~~years of age, who are deaf as well as blind and for which there are no~~  
18 ~~facilities for education in this state, to any school, institution, or other~~  
19 ~~place outside the State of Arkansas providing a qualified program of~~  
20 ~~education for such children.~~

21 ~~(b) The funds may be spent for room, board, tuition, transportation,~~  
22 ~~and other items which are necessarily relevant to the education of such~~  
23 ~~children.~~

24 ~~(c) In interpreting and carrying out the provisions of this section,~~  
25 ~~the words "deaf blind children", wherever used, will be construed to include~~  
26 ~~any child whose combination of disabilities of deafness and blindness would~~  
27 ~~prevent him or her from profiting satisfactorily from educational programs~~  
28 ~~now provided for the blind child or the deaf child by the State of Arkansas.~~

29 ~~(d) The school is authorized to determine if such children should be~~  
30 ~~sent to such out-of-state facilities.~~

31 ~~(e) The school is authorized to promulgate such rules as it deems~~  
32 ~~necessary and proper for carrying out the purposes and intent of this~~  
33 ~~section.~~

34  
35 ~~6-43-107. Application for admission — Certificate of residence.~~

36 ~~Whenever application is made for the admission of any blind or Deaf,~~

~~1 deaf, or Hard of Hearing person into the Arkansas School for the Blind or the  
2 Arkansas School for the Deaf, as a beneficiary of the privileges thereof, the  
3 application shall be accompanied by the certificate of the county judge that  
4 the person is a legal resident of the county of the State of Arkansas in  
5 which it is claimed that he or she resides.~~

6 (a) All students between the ages of three (3) and twenty-one (21) who  
7 are blind or visually impaired or who are deaf or hard of hearing and who  
8 reside in the State of Arkansas shall be eligible to apply and be referred  
9 for admission to the Arkansas School for the Deaf and Blind at no cost to the  
10 student or the parent, legal guardian, or person standing in loco parentis to  
11 the student.

12 (b) The Board of Trustees of the Arkansas School for the Deaf and  
13 Blind may adopt an admission policy, including requirements for admission to  
14 the Arkansas School for the Deaf and Blind, that is necessary to ensure  
15 compliance with the purpose and function of the Arkansas School for the Deaf  
16 and Blind.

17 (c)(1) A public school district, an open-enrollment public charter  
18 school, an education service cooperative, or an early childhood facility that  
19 receives state or federal funds shall at least annually at an individualized  
20 education program meeting share information with a parent, legal guardian, or  
21 person standing in loco parentis to a student regarding services available  
22 from the Arkansas School for the Deaf and Blind and whether the Arkansas  
23 School for the Deaf and Blind is the appropriate placement for a student if  
24 the student:

25 (A) Is between the ages of three (3) and twenty-one (21);

26 (B) Qualifies under the Individuals with Disabilities  
27 Education Act, 20 U.S.C. § 1400 et seq., as it existed on January 1, 2025;  
28 and

29 (C) Is blind, visually impaired, deaf, or hard of hearing.

30 (2) If the individualized education program team determines that  
31 the Arkansas School for the Deaf and Blind is the appropriate placement for a  
32 student, a referral on behalf of the student shall be made to the Arkansas  
33 School for the Deaf and Blind.

34 (3)(A) If the individualized education program team does not  
35 determine that the Arkansas School for the Deaf and Blind is the appropriate  
36 placement for a student, the parent, legal guardian, or person standing in



1 loco parentis to the student may submit an application for admission to the  
 2 Arkansas School for the Deaf and Blind in accordance with Arkansas School for  
 3 the Deaf and Blind policy.

4 (B) A student who is accepted for admission to the  
 5 Arkansas School for the Deaf and Blind under subdivision (c)(3)(A) of this  
 6 section shall unenroll from the school in which he or she is currently  
 7 enrolled and the Arkansas School for the Deaf and Blind shall become  
 8 responsible for all requirements under the student's individualized education  
 9 program.

10 (d) An eligible student from outside the state may be admitted to the  
 11 Arkansas School for the Deaf and Blind upon the payment of tuition and fees  
 12 in accordance with Arkansas School for the Deaf and Blind policy.

13 (e) A student who is older than twenty-one (21) years of age who is  
 14 blind or visually impaired or who is deaf or hard of hearing may attend the  
 15 Arkansas School for the Deaf and Blind in order to access career and  
 16 technical programs made available by the Arkansas School for the Deaf and  
 17 Blind in accordance with Arkansas School for the Deaf and Blind policy.

20 ~~(a)(1) Whenever it shall be deemed necessary by the proper officers of~~  
 21 ~~either the Arkansas School for the Blind or the Arkansas School for the Deaf,~~  
 22 ~~in accordance with the bylaws and rules thereof, to have pupils removed,~~  
 23 ~~either temporarily on account of ill health or the vacation of the Arkansas~~  
 24 ~~School for the Blind or the Arkansas School for the Deaf, or permanently on~~  
 25 ~~account of having completed their course of instruction or having been found~~  
 26 ~~disqualified, from any cause, for a longer continuance in the Arkansas School~~  
 27 ~~for the Blind or the Arkansas School for the Deaf, the parents, or guardians,~~  
 28 ~~if they have any, of such pupils shall promptly remove them upon the~~  
 29 ~~requirement of the officers~~ The Board of Trustees of the Arkansas School for

9 ~~(a) When such persons, upon proper application, are admitted as pupils~~  
10 ~~of either the Arkansas School for the Blind or the Arkansas School for the~~  
11 ~~Deaf, it shall be the duty of their parents, guardians, or other friends to~~  
12 ~~suitably provide them with clothing at the time of their entrance into the~~  
13 ~~Arkansas School for the Blind or the Arkansas School for the Deaf, and during~~  
14 ~~their continuance therein, and to defray their traveling expenses to and from~~  
15 ~~the institution, not only at the time of their first entrance and final~~  
16 ~~departure but at any other time when it shall become necessary for them to~~  
17 ~~leave or return to the Arkansas School for the Blind or the Arkansas School~~  
18 ~~for the Deaf.~~

19 ~~(b)(1)(A) In all cases in which suitable clothing and means for~~  
20 ~~defraying traveling expenses are not otherwise supplied to the pupils of the~~  
21 ~~schools, suitable clothing and means of defraying travel expenses shall be~~  
22 ~~provided by the superintendent or principal of the respective schools, who~~  
23 ~~shall make out and file with the Auditor of State accounts for the clothing~~  
24 ~~and travel expenses, separate in each case, against the respective counties~~  
25 ~~from which such pupils are sent, in an amount not exceeding forty dollars~~  
26 ~~(\$40.00) per annum for any one (1) pupil.~~

27 ~~(B) The accounts shall be severally signed by the proper~~  
28 ~~superintendent or principal.~~

29 ~~(2) The Auditor of State shall draw his or her warrant on the~~  
30 ~~Treasurer of State for the amounts, which shall be paid out of any money in~~  
31 ~~the State Treasury not otherwise appropriated.~~

32 ~~(3) However, the amount drawn by either institution for the~~  
33 ~~aforsaid purposes per year shall not exceed two thousand dollars (\$2,000).~~

34 ~~(4) Each account thus certified shall be charged to the county~~  
35 ~~from which the pupil named therein was sent.~~

36 ~~(5)(A) The Auditor of State shall forward a certified copy of~~

1 ~~each account so filed with him or her to the sheriff of the proper county,~~  
2 ~~who shall proceed to collect the account in the name of the State of~~  
3 ~~Arkansas, as other debts are collected, and the money so collected shall be~~  
4 ~~paid over to the Treasurer of State, who shall give receipts therefor as in~~  
5 ~~case of other moneys paid into the State Treasury.~~

6 ~~(B) However, if the sheriff shall be unable to collect the~~  
7 ~~amount of any bill from the parents or estate of any pupil, then the bill~~

10 ~~6-43-110. Clothing and travel expenses — Warrants.~~

11 ~~(a) It shall be the duty of the sheriffs of this state to receive from~~  
12 ~~the county clerks all warrants ordered by their respective county courts by~~  
13 ~~virtue of § 6-43-109(b)(5) and present them to the county treasurer for~~  
14 ~~payment.~~

15 ~~(b)(1) The county treasurer of the proper county shall pay the~~  
16 ~~warrants on presentation from any money on hand and appropriated for pauper~~  
17 ~~purposes.~~

18 ~~(2) However, if there is no money in the county treasurer's~~  
19 ~~hands from which to pay off the warrants, he or she shall endorse the fact on~~  
20 ~~the warrants, date and sign the endorsement, and return them to the sheriff.~~

21 ~~(c)(1) The Treasurer of State is authorized to receive from the~~  
22 ~~several sheriffs and collectors of the state any and all such warrants as may~~  
23 ~~be ordered and issued in payment for clothing and expenses of indigent pupils~~  
24 ~~in the Arkansas School for the Blind or the Arkansas School for the Deaf by~~  
25 ~~the county courts of the counties that are or may be liable for such~~  
26 ~~expenses.~~

27 ~~(2) The warrants shall be drawn in favor of the state, shall~~  
28 ~~state on their face the name of the pupil or inmate whose expenses are~~  
29 ~~thereby refunded, and shall be endorsed as required by subsection (b) of this~~  
30 ~~section.~~

31 ~~(d) The Treasurer of State is authorized to apply such county warrants~~  
32 ~~so received in payment of the Auditor of State's warrants drawn in favor of~~  
33 ~~the counties for funds received from sales or redemption of lands in lieu of~~  
34 ~~any currency in his or her hands from the source belonging to the respective~~  
35 ~~counties whose warrants he or she holds, replacing the county warrants with~~  
36 ~~the currency.~~

1           ~~(e) The State Board of Finance may biennially in October make such~~  
2 ~~disposition of the county warrants so received and not converted into par~~  
3 ~~funds, as provided in subsection (d) of this section, as shall in the~~

9           ~~In case of the death of any pupil at the Arkansas School for the Blind~~  
10 ~~or the Arkansas School for the Deaf, when funeral expenses are not otherwise~~  
11 ~~provided for, an account thereof shall be made out, certified to, collected,~~  
12 ~~and applied as provided in § 6-43-109.~~

14           ~~6-43-112. Transportation of students~~ Student transportation.

15           (a) The Arkansas School for the Deaf and the Arkansas School for the  
16 Blind are hereby authorized to may transport students to and from school in  
17 chartered vehicles that are licensed to do business in the State of Arkansas  
18 and ~~which~~ meet minimum safety standards established by the United States  
19 Department of Transportation.

20           (b) The school may spend general revenue funds to provide  
21 transportation services, including without limitation transportation via bus,  
22 motor vehicle, or airline if traveling out of state.

23  
24           ~~6-43-113. Compensation limitation.~~

25           ~~(a) No employee drawing a salary or other form of compensation from~~  
26 ~~the Arkansas School for the Blind or the Arkansas School for the Deaf shall~~

35 during the middle of a school year, there would be significant disruptions in  
36 funding and confusion among administration, staff, students, and parents of

1 students; and that this act is immediately necessary to ensure that the  
2 necessary changes in implementing the merger of the Arkansas School for the  
3 Blind and Arkansas School for the Deaf are made before the 2025-2026 school  
4 year and to guarantee funds for the Arkansas School for the Deaf and Blind  
5 are correctly appropriated in advance of the upcoming 2026 fiscal year.  
6 Therefore, an emergency is declared to exist, and this act being immediately
