13	<u>(\$5,000); or</u>
14	(D) For a fourth or subsequent offense occurring within
15	ten (10) years of the first offense, an unclassified felony punishable by
16	imprisonment for not less than one (1) year but no more than six (6) years
17	and a fine not less than nine hundred dollars (\$900) but no more than five
18	thousand dollars (\$5,000).
