AN AMENDMENT TO THE ARKANSAS CONSTITUTION TO CREATE

13

"THE CITIZENS ONLY VOTING AMENDMENT"; TO PROVIDE THAT

14

ONLY A CITIZEN OF THE UNITED STATES MEETING THE

15

QUALIFICATIONS OF AN ELECTOR UNDER THE ARKANSAS

16

CONSTITUTION MAY VOTE IN AN ELECTION IN THIS STATE;

17

AND PROVIDING THAT A PERSON WHO DOES NOT MEET THE

18

QUALIFICATIONS OF AN ELECTOR UNDER THE ARKANSAS

CONSTITUTION SHALL NOT BE PERMITTED TO VOTE IN ANY

STATE OR LOCAL ELECTION HELD IN THIS STATE.

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL

27

ASSEMBLY OF THE STATE OF ARKANSAS, AND BY THE SENATE, A MAJORITY OF ALL

28

MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:

THAT the following is proposed as an amendment to the Constitution of

31

the State of Arkansas, and upon being submitted to the electors of the state

32

for approval or rejection at the next general election for Representatives

33

and Senators, if a majority of the electors voting thereon at the election

34

adopt the amendment, the amendment shall become a part of the Constitution of

35

the State of Arkansas, to wit:

1 SECTION 1. Short title. This amendment to the Arkansas Constitution
2 shall be known and may be cited as "The Citizens Only Voting Amendment."

3
4 SECTION 2. Arkansas Constitution, Article 3, § 1, is amended to read
5 as follows:

6 § 1. Qualifications of electors.

7 (a)(1) Only a citizen of the United States meeting the qualifications
8 of an elector under this section may vote in an election in this state.

9 (2) A person who does not meet the qualifications of an elector
10 under this section shall not be permitted to vote in any state or local
11 election held in this state.

12 ~~(a)(b)~~ Except as otherwise provided by this Constitution, ~~any person~~
13 ~~may vote in an election in this state who~~ to vote in an election in this
14 state a person shall be:

15 (1) A citizen of the United States;

16 (2) A resident of the State of Arkansas;

17 (3) At least eighteen (18) years of age; and

18 (4) Lawfully registered to vote in the election.

19 ~~(b)(1)(c)(1)~~ In addition to the qualifications under subsection ~~(a)(b)~~
20 of this section, the General Assembly shall provide by law that a voter
21 shall:

22 (A) Present valid photographic identification before
23 receiving a ballot to vote in person; and

24 (B) Enclose a copy of valid photographic identification
25 with his or her ballot when voting by absentee ballot.

26 (2) The General Assembly shall establish by law the types of
27 photographic identification that a person may present to comply with
28 subdivision ~~(b)(1)(c)(1)~~ of this section.

29 ~~(e)(d)~~ The State of Arkansas shall issue photographic identification
30 at no charge to an eligible voter who does not have a form of photographic
31 identification meeting the requirements of the law enacted by the General
32 Assembly under this section.

33 ~~(d)(1)(A)(e)(1)(A)~~ A voter unable to present valid photographic
34 identification when voting in person shall be permitted to vote a provisional
35 ballot.

36 (B) An absentee ballot that is not accompanied by a copy

1 of valid photographic identification shall be considered a provisional
2 ballot.

3 (2) A provisional ballot under subdivision ~~(d)(1)~~(e)(1) of this
4 section shall be counted only if the voter subsequently certifies the
5 provisional ballot in a manner provided by law.

6 ~~(e)(1)~~(f)(1) The General Assembly shall implement the provisions of
7 this amendment by law.

8 (2) The General Assembly may provide by law for exceptions to
9 the requirement that a voter:

10 (A) Present valid photographic identification before
11 receiving a ballot to vote in person; and

12 (B) Enclose a copy of valid photographic identification
13 with his or her ballot when voting by absentee ballot.

14 ~~(f)~~(g) A voter meeting the requirements of this section also shall
15 comply with all additional laws regulating elections necessary for his or her
16 vote to be counted.

18 SECTION 3. EFFECTIVE DATE. This amendment is effective on and after
19 January 1, 2027.

20

21 SECTION 4. BALLOT TITLE AND POPULAR NAME. When this proposed
22 amendment is submitted to the electors of this state on the general election
23 ballot:

24 (1) The title of this Joint Resolution shall be the ballot
25 title; and

26 (2) The popular name shall be "A Constitutional Amendment to be
27 Known as "The Citizens Only Voting Amendment" and Providing That Only a
28 Citizen of the United States Meeting the Qualifications of an Elector Under
29 the Arkansas Constitution May Vote in an Election in this State.".
