9	TO RECOGNIZE FEBRUARY 10, 2025, AS KIDS COUNT DAY AT
10	THE STATE CAPITOL, AND TO RECOGNIZE THE ARKANSAS KIDS
11	COUNT COALITION FOR ITS ADVOCACY ON BEHALF OF THE
12	CHILDREN OF ARKANSAS.

16	TO RECOGNIZE FEBRUARY 10, 2025, AS KIDS
17	COUNT DAY AT THE STATE CAPITOL, AND TO
18	RECOGNIZE THE ARKANSAS KIDS COUNT
19	COALITION FOR ITS ADVOCACY ON BEHALF OF
20	THE CHILDREN OF ARKANSAS.

22	WHEREAS, the Arkansas Kids Count Coalition is a membership coalition
23	comprised of diverse individuals and organizations concerned about policies
24	impacting children in Arkansas, and is staffed by Arkansas Advocates for
25	Children and Families; and
26	
27	WHEREAS, the Arkansas Kids Count Coalition serves as a strong,
28	independent nongovernmental grassroots voice for the children of Arkansas,
29	providing education and policy resources to support advocacy for the well-
30	being of all Arkansas children; and
31	
32	WHEREAS, when the Arkansas Kids Count Coalition was founded in 1996,
33	one (1) in four (4) Arkansas children lived in poverty, but today those
34	figures have dropped to only one (1) in five (5); and
35	
36	WHEREAS, the membership of the Arkansas Kids Count Coalition is

1	composed of twenty-six (26) organizations and one hundred four (104)
2	individuals who live across Arkansas, from Marianna to Lowell to Jonesboro to
3	Hot Springs; and
4	
5	WHEREAS, the members of the Arkansas Kids Count Coalition work to
6	improve the mental health of families, and function as nonprofits alleviating
7	hunger in their communities; and
8	
9	WHEREAS, the members of the Arkansas Kids Count Coalition are retired
10	educators and parents who want to improve the lives of all the children of
11	Arkansas, no matter where those children are from or what they look like; and
12	
13	WHEREAS, throughout each year, the members of the Arkansas Kids Count
14	Coalition connect with and educate advocates around Arkansas, giving them
15	tools and resources to lobby Arkansas lawmakers regarding the well-being of
16	Arkansas children; and
17	
18	WHEREAS, in 2024, the Arkansas Kids Count Coalition hosted fourteen
19	(14) events in eight (8) towns in Arkansas and online, with four hundred
20	forty-two (442) total attendees; and
21	
22	WHEREAS, on February 10, 2025, the members of the Arkansas Kids Count
23	Coalition will be at the State Capitol to celebrate the biannual Kids Count
24	Day at the State Capitol; and
25	
26	WHEREAS, because of the advocacy of the members of the Arkansas Kids
27	Count Coalition, the members of the General Assembly, and Arkansas citizens
28	who lifted up the voices of children, continued progress has been seen in the
29	well-being of Arkansas children; and
30	
31	WHEREAS, the Arkansas Kids Count Coalition believes that laws are made
32	by the people who show up and vows to continue to show up for Arkansas
33	children and ensure that Arkansas continues to make progress in improving the
34	lives of the children of Arkansas,

1	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL
2	ASSEMBLY OF THE STATE OF ARKANSAS:
3	
4	THAT the House of Representatives recognize February 10, 2025, as Kids
5	Count Day at the State Capitol and recognize the Arkansas Kids Count
6	Coalition for its advocacy for Arkansas children.
7	
8	BE IT FURTHER RESOLVED THAT upon adoption, a copy of this resolution be
9	provided to the membership of the Arkansas Kids Count Coalition by the Chief
10	Clerk of the House of Representatives.
