15	TO RECOGNIZE THE MOUNTAIN HOME BOMBERS
16	HIGH SCHOOL BOYS' INDOOR TRACK TEAM AS
17	THE CLASS 5A STATE CHAMPIONS.

19	WHEREAS, the Mountain Home High School Bombers boys' indoor track team
20	claimed its first Class 5A Indoor Track and Field state championship on
21	February 22, 2025, at the Randal Tyson Track Center on the campus of the
22	University of Arkansas in Fayetteville; and
23	
24	WHEREAS, team member Connor King finished first in the eight-hundred-
25	meter and sixteen-hundred-meter runs, and bested his personal record by three
26	(3) seconds; and
27	
28	WHEREAS, team member Eli Jones finished first in the shot put
29	competition and bested the school record he had set by six inches (6"); and
30	
31	WHEREAS, team member Eston Ford had only been training in shot put for
32	two (2) months before the championship, and Head Coach Noah Chagnon noted
33	that the team won the shot put competition overall by only half (1/2) a point
34	and that Ford scored two (2) of the team's points, helping to secure the
35	victory; and

1	WHEREAS, team member Jackson Free finished first in the thirty-two-
2	hundred-meter run and finished second in the sixteen-hundred-meter run, and
3	bested his personal record by three (3) seconds; and
4	
5	WHEREAS, team member Garrett Barr finished second in the thirty-two-
6	hundred-meter run; and
7	
8	WHEREAS, team member Taylon Peterson finished third in the triple jump;
9	and
10	
11	WHEREAS, team members Connor King, Trenton Smith, Jackson Free, and
12	Garrett Barr won the four-by-eight-hundred-meter relay; and
13	
14	WHEREAS, team members Connor Schulz, Ben Souder, Talan Palmer, and Zach
15	Daugherty finished third in the four-by-four-hundred-meter relay; and
16	
17	WHEREAS, Head Coach Noah Chagnon noted that the conference is
18	particularly competitive in pole vault, and that the Bombers' competitors in
19	pole vault did extremely well in comparison with the winner, with team member
20	Zach Daugherty finishing fourth in pole vault at fifteen feet, six inches
21	(15'6") and team member Adam Jones finishing sixth in pole vault at fourteen
22	feet, six inches (14'6"); and

24	WHEREAS, the Bombers were led by Head Coach Noah Chagnon and coaches
25	Tilda Helgesson, Wil Norris, Andy Alman, Jose Jiminez, and Philip Goodwin;

28	WHEREAS, Head Coach Noah Chagnon said of the team, "We've had a lot of
29	success on the cross country side of things lately, and our track progress
30	has started to join in with that. In the last few years, we've had preseason
31	training and more buy-in from the kids, more numbers, more participation. The
32	kids are owning their training and showing up and the training is paying off.
33	I'm so thankful for our coaches; they really care and take every practice
34	seriously. The winning combination is our kids working so hard and these
35	coaches putting it all together",
