3	WHEREAS, the Down Syndrome Connection of Northwest Arkansas's 2024
4	Impact Report shows that the organization served two hundred eighty-eight
5	(288) families impacted by Down Syndrome, delivered seventeen (17) new parent
6	baskets, donated nine hundred seventy (970) hours of service via one hundred
7	ninety-one (191) volunteers, and raised one hundred eighteen thousand two
8	hundred eighty-five dollars (\$118,285) for the local community; and
