25	SECTION 1. DO NOT CODIFY. Legislative intent.
26	It is the intent of the General Assembly that:
27	(1) This act provide a pension-owned life insurance policy as a
28	benefit to the members of the public employee retirement systems;
29	(2) The pension-owned life insurance policies for the members of
30	the respective state retirement systems be owned by each respective system
31	and provided to each member of the system;
32	(3) Each state retirement system has the ability to offer life
33	insurance as a survivor's benefit to each member;
34	(4) No state retirement system shall be required to offer this
35	benefit; and
36	(5) If life insurance is offered as a survivor's benefit to the

1	members of a state retirement system, the life insurance payment shall be a
2	set amount paid to the member's beneficiary, less any overpayments, with the
3	remaining balance to be used to lessen the system's unfunded liabilities.

6	to add an additional section to read as follows:
7	24-4-624. Life insurance — Payment to beneficiary.
8	(a) The Arkansas Public Employees' Retirement System may provide a
9	life insurance benefit to the beneficiary of a deceased member.
10	(b) The Board of Trustees of the Arkansas Public Employees' Retirement
11	System shall promulgate rules to implement this section.
