19	BE IT ENACTED BY THE GENERAL	ASSEMBLY OF THE STATE OF A	RKANSAS:

21	SECTION 1. Arkansas (Code § 20-8-107(a), concerni	ng the expansion of
22	facilities and services under the Health Services Permit Agency, is amended		
23	to read as follows:		
24	(a) <u>(l)</u> Unless otherwi	ise provided in this subchap	ter, all health
25	facilities seeking to add ne	ew beds or perform additiona	l home health services
26	or to expand existing bed ca	apacity shall apply for a pe	rmit approving
27	additional beds or services	or expanded bed capacity or	services pursuant to
28	procedures and criteria prom	nulgated by the Health Servi	ces Permit Commission,
29	except an additional permit	shall not be required for:	
30	(A) Home	$\frac{\mbox{\sc home}}{\mbox{\sc health}}$ health services agenci	es currently licensed
31	by the Department of Health to expand geographic service areas if the home		
32	health services agency has a primary or branch office located within one		
33	hundred (100) miles of the location of the services; or		
34	(B) Hospice agencies currently licensed by the Department		
35	of Health to expand geographic service areas if the hospice agency has a		
36	primary or branch office located within one hundred (100) miles of the		

1	location of the services.	
2	(2)(A) A home health services agency or a hospice agency shall	
3	not expand its service area except on the first day of a calendar quarter.	
4	(B) If a home health services agency or hospice agency	
5	seeks to expand its service area on the first day of a calendar quarter, the	
6	home health services agency or hospice agency shall notify the Department of	
7	Health and the Health Services Permit Agency at least forty-five (45) days in	
8	advance of providing any services in the expanded area.	
9	(3) The Department of Health and the Health Services Permit	
10	Agency shall record any expansion in service area in its publicly distributed	
11	records.	
12	(4) A home health service agency or a hospice agency that is	
13	providing services outside of a permitted service area shall be subject to	
14	appropriate penalties under § 20-7-101 and § 20-10-803.
