23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25	SECTION 1. Arkansas Code Title 6, Chapter 18, Subchapter 2, is amende	d
26	to add an additional section to read as follows:	
27	6-18-237. Participation of private school students in interscholastic	
28	activities at public schools — Definitions.	
29	(a) As used in this section:	
30	(1) "Athletic activity" means a varsity sport or another	
31	competitive sports-related contest, game, event, or exhibition that involves	-
32	an individual student or teams of students either among schools within a	
33	resident school district or between schools outside of the resident school	
34	district;	
35	(2) "Interscholastic activity" means an activity between school	s
36	subject to rules of the Arkansas Activities Association that is:	

1	(A) Outside the regular curriculum of a public school
2	district, including without limitation an athletic activity, a fine arts
3	program, or a special interest club or group; and
4	(B) Taught by an individual with a minimum of a high
5	school diploma;
6	(3) "Parent" means a parent, legal guardian, or person standing
7	in loco parentis to a child;
8	(4) "Private school" means a nonpublic elementary or secondary
9	school that is:
10	(A) A registered nonprofit; and
11	(B) Accredited or licensed by an accrediting association
12	recognized by the State Board of Education;
13	(5) "Resident school" is a public school to which a student
14	would be assigned by the student's resident school district; and
15	(6) "Resident school district" means a public school district in
16	which a private school student's parent resides as determined under § 6-18-
17	<u>202.</u>
18	(b) A resident school district may permit a private school student to
19	pursue participation in an interscholastic activity at the resident school
20	district if the private school in which the student is enrolled does not have
21	the interscholastic activity in which the private school student seeks to
22	participate approved by the Arkansas Activities Association.
